


Case Study



“Kernel Data Recovery Resolved the Corruption Issues that Restricted Access of Outlook Mailbox information.

Background

Strong Abogados is a noted organization engaged in offering wide range of business services to its clients including accountants, tax/corporate lawyers, payroll specialists and many more. The company approached Kernel Data Recovery Company, when Tom Strong who is one of their employees was unable to open Outlook mailbox data items, due to the corruption issues in PST files. The client was looking for a quick and reliable solution, where the emails can be accessed in European date format (DD-MM-YYYY format) to maintain the lawsuit.

Subject

When the oversizing issues in PST files is not properly handled, then there are higher chances of getting the data files corrupted. This was the exact scenario faced by the client where PST files got corrupt upon crossing the predefined size.

Cause

Over the years of rigorous usage, the client had accumulated the tons of data files in his mailbox. Eventually it resulted in the exceeding of the predefined size of the mailbox quota, and the client was unable to perform send/receive operations, moving the items or archiving the PST files. Oversizing of PST files was the reason, which has led to the corruption of data files and eventually restrained to access the mailbox information.


Solution
