1. Introduction to Kernel for Macintosh

Welcome to the user manual for Kernel for Macintosh, the most powerful and professional data recovery software that helps you to recover Mac data from formatted, damaged, or corrupted volumes and even from initialized disks. This user manual comprises step by step guidelines on using Kernel for Macintosh.

1.1 Using this Manual

This user manual is intended to guide users on using Kernel for Macintosh. We suggest that first time users should read this user manual completely and carefully before proceeding to use the software. However, if you are an experienced user, you can use the table of contents to find out information pertaining to the tasks that you need to perform by using Kernel for Macintosh.

1.2 About Kernel for Macintosh

Kernel for Macintosh is data recovery software which recovers Mac operating system data. The reason for data loss could be:

- Bad Sector in the Disk
- Disk Initialization
- Master Directory Block or Volume Header Corruption
- Catalog File Corruption
- Extents or Extents Overflow file corruption
- Catalog File's node corruption
- Partition Table Corruption

Kernel for Macintosh recovers data from deleted, formatted, damaged, or corrupted volumes and even from initialized Mac hard disks. It recovers data from crashed Mac drives of eMac, iMac, iBook, iPod instantly.

1.3 Salient Features

Salient features of Kernel for Macintosh include:

- Recovers partition if partition are deleted or formatted
- Recovery from Lost or Missing Mac folders
- Support for all versions of Macintosh (HFS, HFS+)
- User friendly graphical user interface
- Recognizes and preserves long file names when recovering Mac files & folders
- Full support for IDE, EIDE, SCSI and SATA drives
- Free demo to experience the capabilities of the tool before purchasing it

1.4 Who Should Use this Software?

The capability of Kernel for Macintosh to recover Mac operating system corrupt, damaged, deleted data makes it appropriate for use by professionals, individuals, organizations who have Macintosh operating system installed on their system. The corruption could have happen to Mac data due to bad sector in disk, disk initialization, catalog file corruption, partition table corruption, etc. Kernel for Macintosh proves useful in these cases of Mac data corruption.

2. Getting Started

Now that you have understood the features and potential of Kernel for Macintosh, you are ready to get a hand on experience of the software. To start recovering Mac data, you will first need to download and install this software.

It is strongly recommended that before installing Kernel for Macintosh, you should go through the installation pre-requisites for the software to ensure that your computer is appropriately configured to run the software.


2.1 Installation Pre-requisites

The various pre-requisites for installing and running Kernel for Macintosh can be broadly classified into two major categories – Hardware requirements and Software requirements.

2.1.1 Hardware Requirements:

The hardware requirements for installing the software are as follows:

- Pentium Class Processor
- Minimum 64MB RAM (128 MB recommended)
- 10MB for Software installation
- Disk Space - Enough space to save the recovered files

 You should have at-least 10 MB of free disk space if you want to repair and save a 10 MB Mac data.

2.1.2 Software Requirements:

The software requirements for installing the software can further be grouped into two categories– Operating system requirements and Macintosh file system version requirements. The requirements are as follows:

2.1.2.1 Operating System Requirements

Supported operating systems:

- Windows Vista
- Windows XP
- Windows 2003
- Windows 2000

- Windows NT
- Windows ME
- Windows 98
- Windows 95

2.1.2.2 Macintosh File System Version Requirements

Supported Macintosh File System Version:


- HFS Apple Mac OS X
- HFS+ Apple Mac OS X
- HFS Apple Mac OS 9.x and higher
- HFS+ Apple Mac OS 9.x and higher

2.2 Downloading Kernel for Macintosh for the First Time

After checking your computer with the prescribed system requirements for Kernel for Macintosh, you can download and install the software on your computer. You can buy the full version of the software from any one of our authorized resellers – Element5, Asknet and 2CO.

If you want to try using Kernel for Macintosh before buying it, you can download the evaluation version from the following link:

 You can recover Mac data files by using the evaluation version of Kernel for Macintosh; however, the recovered file will not be saved until you purchase full version of the software.

2.3 Install Kernel for Macintosh

After downloading the installer file for Kernel for Macintosh, you can install the software by running the file. To install Kernel for Macintosh:

1. Double-click the Kernel for Macintosh installer. Follow the on-screen instructions.

The **Setup Installation Complete** screen will be displayed.

2. Click **Finish** to launch the software.

2.4 Start Kernel for Macintosh

To start Kernel for Macintosh:

Click the **Start → All Programs → Kernel for Macintosh**

Alternatively, you can launch Kernel for Macintosh by double-clicking the shortcut icon available on the Desktop and Quick Launch icon.


2.5 Uninstall Kernel for Macintosh

You may need to uninstall and re-install Kernel for Macintosh. To uninstall Kernel for Macintosh:

1. Click the **Start → All Programs → Kernel for Macintosh → Uninstall Kernel for Macintosh**

A warning message will be displayed.

2. Click **'Yes'** to uninstall Kernel for Macintosh.

 Before proceeding to uninstall Kernel for Macintosh, you must ensure that the software is not running.

You can alternatively uninstall Kernel for Macintosh from the **Control Panel** by performing the following steps:

1. Click the **Start Menu → Control Panel** and then double click the **Add or Remove Programs** icon.
2. Select **Kernel for Macintosh** and click **Remove**.

A warning message will be displayed.

3. Click **'Yes'** to uninstall Kernel for Macintosh.

3. Software Interface

Now that Kernel for Macintosh has been installed on your computer, you can start using the software after getting acquainted with the software interface.

3.1 Menu-bar

The menu-bar of Kernel for Macintosh comprises four main menus – Recovery, View, Tools and Help.

3.1.1 Recovery Menu

The **Recovery** menu comprises five menu items.

Menu items in the **Recovery** menu:

Field Name	Field Description
Recover Selected	Select to recover the selected files in right pane of the window
Recover All	Select to recover all files in the right pane of the window
Save Recovery Snapshot	Select to save the scan information about the file(s) and folder(s) that have been found in the recovery process
Load Recovery Snapshot	Select to load the scanned information that has been used using Save Recovery Snapshot
Exit	Select to exit from the software

3.1.2 View Menu

The **View** menu comprises three menu items.

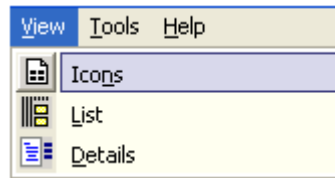


Figure 3.2: View Menu

Menu items in the **View** menu:

Field Name	Field Description
Icons	Select to view the file(s) and folder(s) in Windows standard small icon view style
List	Select to view the file(s) and folder(s) in Windows standard list view style
Details	Select to get the details like File Size, Creation product name, and Type along with the name of the file or folder

3.1.3 Tools Menu

The **Tools** menu comprises five menu items.

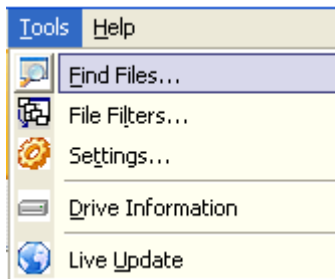


Figure 3.3: Tools Menu

Menu items in the **Tools** menu:

Field Name	Field Description
Find Files	Select for searching a particular file or file type in the data found
File Filters	Select to add filters to the files recovered
Settings	Select to configure the settings of the software
Drive Information	Select to get the information about the file system being recovered
Live Update	Select to update the current software with the available version in the Nucleus server

3.1.4 Help Menu

The **Help** menu comprises three menu items.

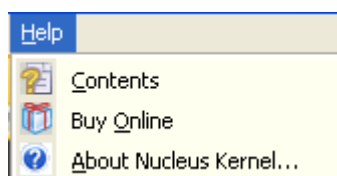








Figure 3.4: Help Menu

Menu items in the **Help** menu:

Field Name	Field Description
Contents	Select to get the Help Guide for the software
Buy Online	Select to open the page on the Internet to buy the software online
About	Select to get the version and other information related to the software

3.2 Tool-bar

The tool-bar in Kernel for Macintosh is displayed below the menu-bar. The tool-bar provides a convenient and user-friendly method to perform certain actions that can also be performed by using the menu-bar. Read the information in the table below to find out about the tool-bar buttons:

Button	Button Name	Button Description
	Recover Selected	Select to recover the selected files in the right pane of the window
	Recover All	Select to recover all files in the right pane of the window
	Save Recovery Snapshot	Select to save the scan information about the file(s) and folder(s)
	Load Recovery Snapshot	Select to load the recovery summary or snapshot saved last time
	Find Files	Select to search for particular files in the current recovery session
	Settings	Select to configure the various options to control over the whole recovery process



Live Update

Select to update the current software with the available version in the Nucleus server

3.3 Buttons Used

Apart from the standard options available in the menu-bar and the tool-bar, three buttons– **Next**, **Back**, **Stop** buttons are displayed on the main window.

	Click to proceed with the recovery process
	Click to go back to the previous window
	Click to stop the searching process

4. Recovering Corrupt Volumes

Now that you have complete familiarity of the user interface of Kernel for Macintosh, you are ready to recover corrupt volumes of Macintosh. To recover volumes:

1. Launch Kernel for Macintosh. As soon the software is launched, it scans all the physical disks attached to your system and displays them.

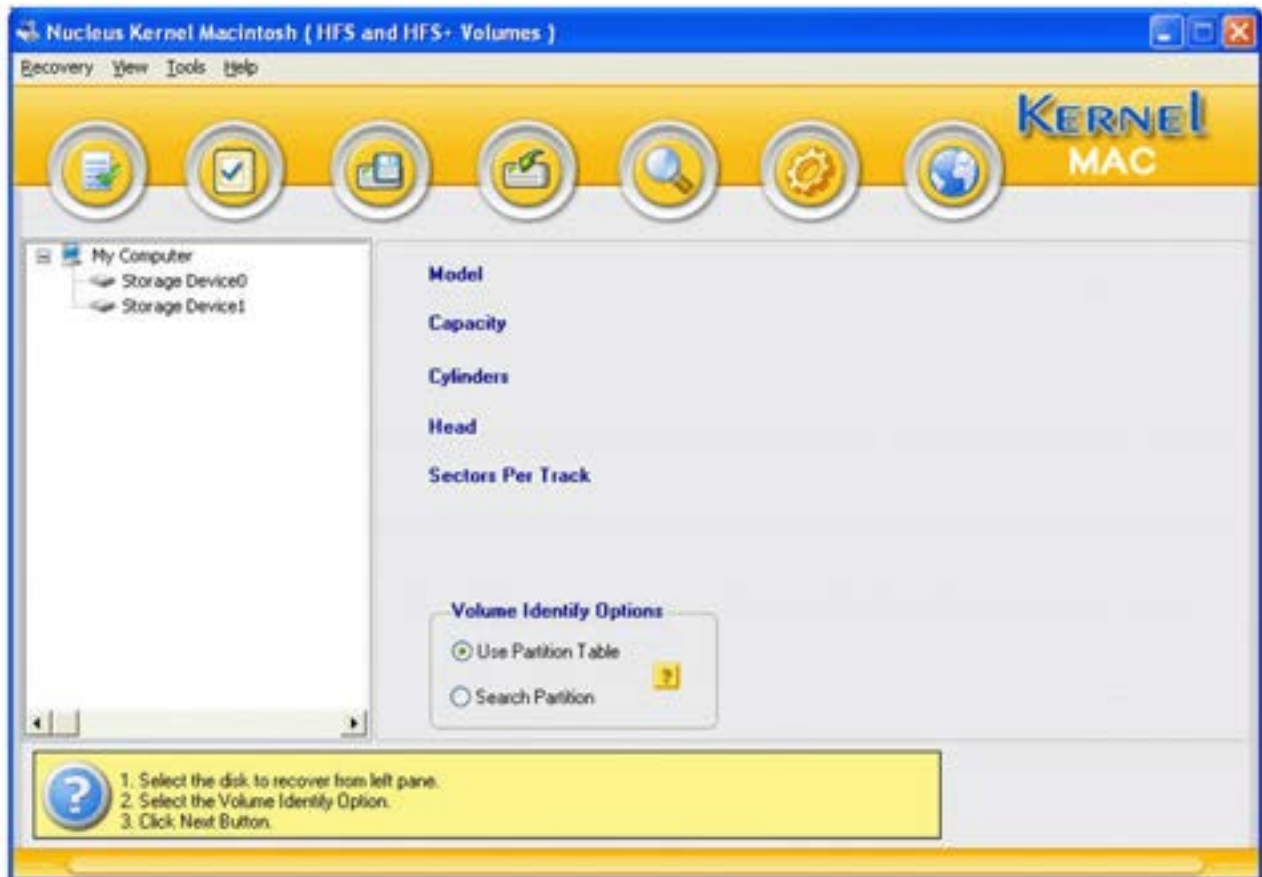


Figure 4.1: Main window showing all physical disks

2. Select the device from where you want to recover the corrupt volume.
3. Select the **Volume Identify Options** from the main window of the software either **Use Partition Table** or **Search Partition**.
 - **Use Partition Table** - This option is the default option to recover corrupt volumes.
 - **Search Partition** - This option will search your partition if you don't get your partition using "Use Partition Table".

4.1 Use Partition Table

To go by **Use Partition Table** option, perform the following:

1. First three steps are same as step 1, 2, 3 of Recovering Corrupt Volumes.
2. Select the **Use Partition Table** option.
3. Click **Next** button to proceed. Kernel will start mounting the volumes.

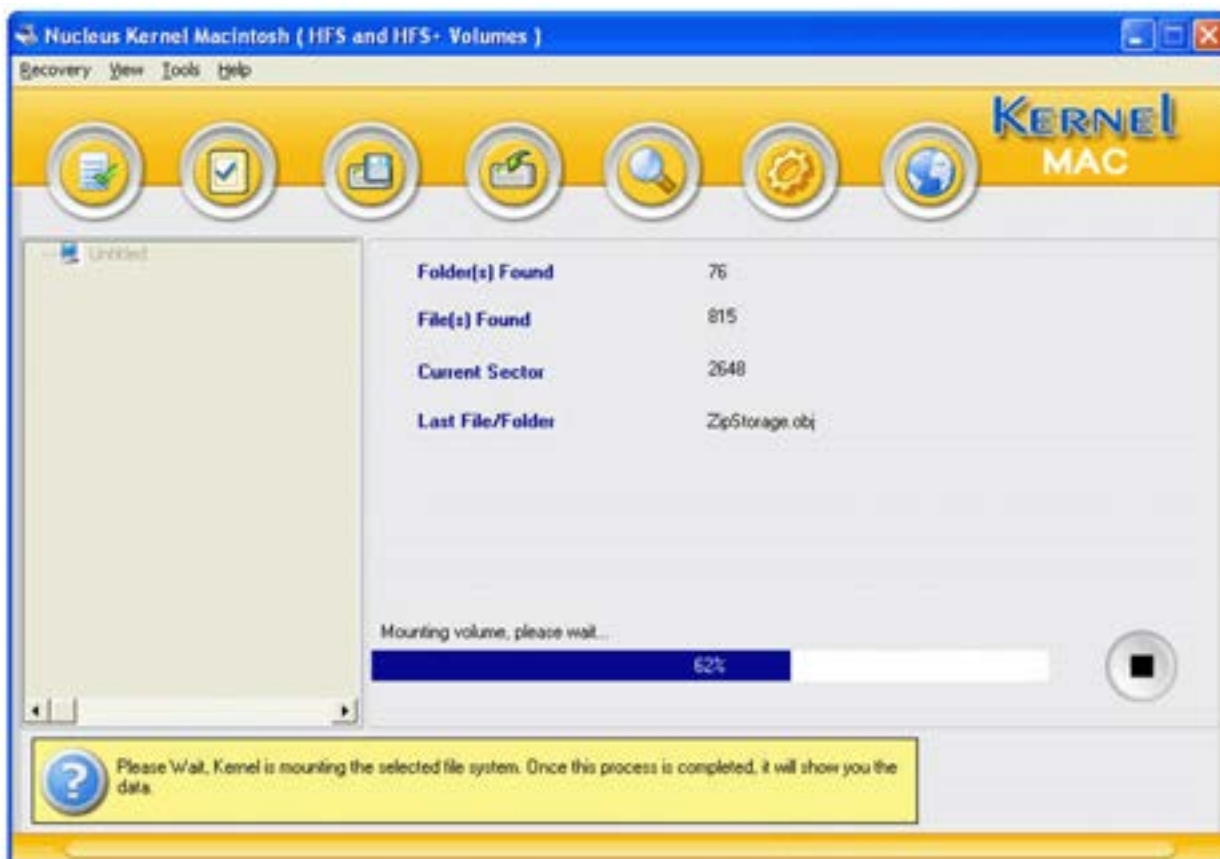


Figure 4.2: Scanning Process

4. As the scanning gets complete, the software displays the recovered files and folders of the selected device.

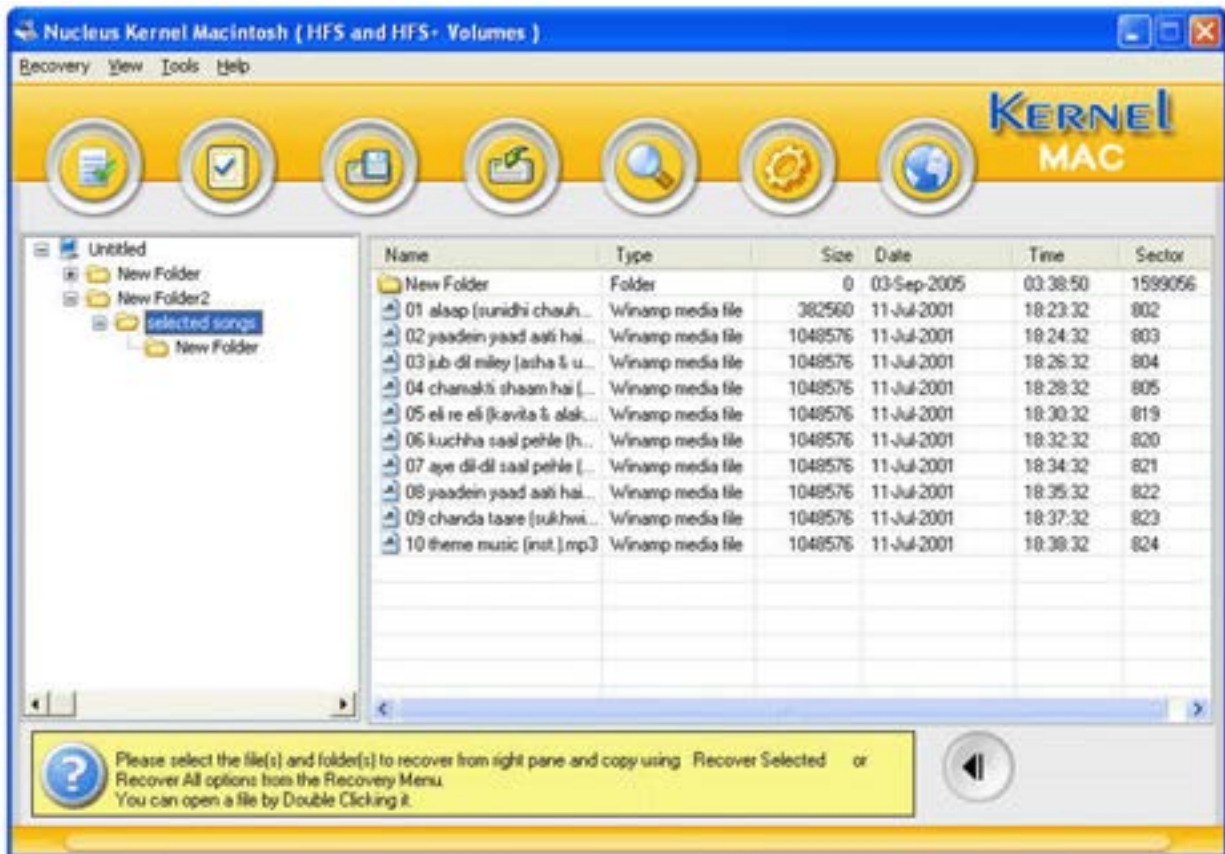


Figure 4.3: Recovered Data

5. Select the files and folders which you want to save from the right pane of the window and copy using **Recover Selected** button in the tool-bar. Save at the appropriate location.

You can also right click and save all file or selected files at appropriate location.

4.2 Search Partition

If you don't get your partition or you have missed the partition then you can use **Search Partition** option to search your missing partitions. To go by **Search Partition** option, perform the following:

1. First three steps are same as step 1, 2, 3 of Recovering Corrupt Volumes.
2. Select the **Search Partition** option from Volume Identify Option.
3. Edit the Start Sector and End Sector to search and click **Next** button to proceed with the next step of searching process. Then after the searching process, it will display all the partitions found during searching process.

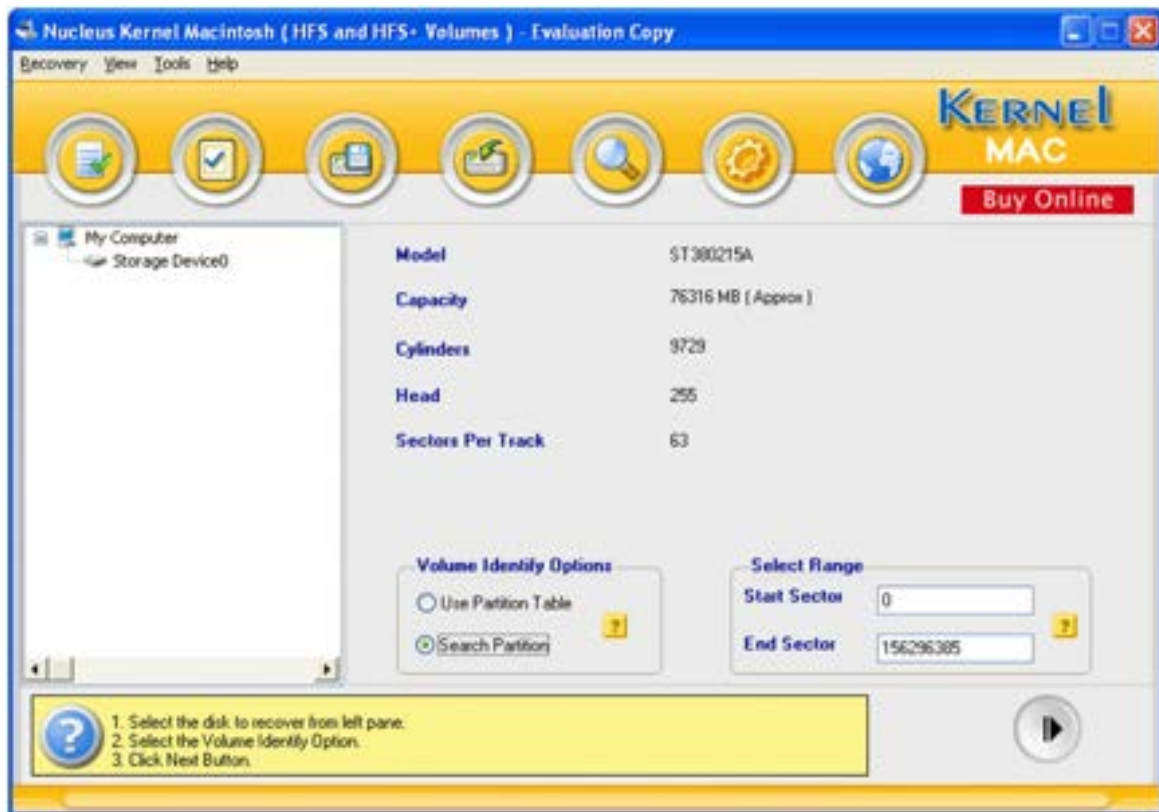


Figure 4.4: Using Search Partition option

4. Select the found partition from which you want to recover data and click **Next** button for recovery process.
5. As the scanning process gets complete, software displays the recovered files and folders of the selected partition.
6. Save the recovered data by selecting the same from the right pane of window and copy using **Recover Selected** button in the tool-bar. Save at the appropriate location.


 You can also right click and save all file or selected files at appropriate location.

5. File Search from Found Data

5.1 File Search

With thousands of files and directories to view, finding a particular file in a directory tree can be difficult. The Search option makes finding the files much easier. This option is modeled after some of the most popular Windows programs, making it very easy to use.

If you know the name or part of the name of the file(s) or folder(s), then follow this step:


- Click **Tools** menu → **Find Files** or click **Search** button  from the Toolbar.
- A new window appears which asks for the string to search.

String could be *, *.TXT, AB*.*, ABC.txt etc.

5.2 File Filters

The Filter feature allows you to filter the files you are interested in by viewing in the directory tree display. There can be a situation when the total found data contains too many file(s) but you only want to recover and see only some application specific data, like all the text file(s). In that situation consider the following:

- Click **Tools** menu → **File Filters**.
- Screen pop-ups which ask for Filter. You can add or remove the filters available accordingly.

 The software will filter only the file(s) that you want to recover and it will hide rest of the file(s).

6. Full Version

Although you can use Kernel for Macintosh evaluation version for free and experience the capabilities of the software, there are certain features that are not available in the evaluation version.

6.1 Requirement of Full Version

By using the evaluation version of Kernel for Macintosh, you can recover the corrupted or deleted data, files and folders. However, you cannot save the recovered data.

You will need to buy the full version of the software to save all the recovered data at the desired location.

6.2 Purchasing Full Version

You can buy the full version of Kernel for Macintosh from any one of our authorized resellers – Element5, Asknet and 2CO.

As soon the purchase transaction with our resellers gets completed, our sales team will send you an email comprising the URL to download the full version of Kernel for Macintosh and activation details of the software.

7. Support

Can I install the software on the same device from which I want to recover deleted file(s)?

First of all, do not install **Kernel Macintosh Data Recovery Software** on the Bad Device. Remember the golden rule of data recovery: Never change anything on the Bad Device!

Even do not install **Kernel Macintosh - Data Recovery Software** on the same drive from which you want to recover deleted file(s) because there is a possibility of overwritten of data.
