1. Introduction to Kernel for IncrediMail

Welcome to the user manual for Kernel for IncrediMail, the most effective and convenient email recovery software that recovers mails from .IMM, IMH and recovers addresses from .IMB files. This user manual comprises step by step guidelines on using Kernel for IncrediMail.

1.1 Using this Manual

This user manual is intended to guide users on using Kernel for IncrediMail. We suggest that first time users should read this user manual completely and carefully before proceeding to use the software. However, if you are an experienced user, you can use the table of contents to find out information pertaining to the tasks that you need to perform by using Kernel for IncrediMail.

1.2 About Kernel for IncrediMail

Kernel Recovery for IncrediMail recovers emails from damaged, corrupt mailbox files. It successfully recovers mails from [IncrediMail .IMM Files, IMH Files] and also recovers addresses from [IncrediMail .IMB Files].

It recovers mails lost due to following reasons:

- Virus Infected or Corrupted mail files
- Accidentally deleted mails
- Media corruption where mails are stored or backed up
- Header corruption of .IMM, IMH and IMB file
- Mails emptied from the "Deleted Items" folder

Kernel for IncrediMail recovers accidentally deleted or sabotaged messages that have been also removed from the "**Deleted Items**" folder in **IncrediMail**.

1.3 Salient Features

Salient features of Kernel for IncrediMail include:

- Recover e-mails from corrupted IncrediMail file (.imh, .imm)
- Recover Address Book from corrupted IncrediMail Address book file(.imb)
- Easy to use recover e-mails and addresses in three steps
- Recover attachments with e-mail
- Employs QFSCI technology for email recovery
- User friendly graphical user interface
- Free demo to know to features and functions of the software

1.4 Who Should Use this Software?

The capability of Kernel for IncrediMail to recover emails with all its attachments from inaccessible, damaged, corrupt IncrediMail mailboxes makes it appropriate for use by professional authors, individuals,



technicians, organization level users who use IncrediMail as their email client. The software is suitable for other IncrediMail users who have lost their important email data due to accidental deletion, virus infection, header corruption, media corruption, etc.

2. Getting Started

Now that you have understood the features and potential of Kernel for IncrediMail, you are ready to get hands on experience of the software. To start the email recovery, you will first need to download and install this software.

It is strongly recommended that before installing Kernel for IncrediMail, you should go through the installation pre-requisites for the software to ensure that your computer is appropriately configured to run the software.


2.1 Installation Pre-requisites

The various pre-requisites for installing and running Kernel for IncrediMail can be broadly classified into two major categories – Hardware requirements and Software requirements.

2.1.1 Hardware Requirements:

The hardware requirements for installing the software are as follows:

- Pentium Class Processor
- Minimum 64MB RAM (128 MB recommended)
- 10MB for Software installation
- Disk Space - Enough space to save the recovered data

 You should have at-least 40 MB of free disk space if you want to repair and save a 40 MB email data.

2.1.2 Software Requirements:

The software requirements for installing the software can further be grouped into two categories– Operating system requirements and IncrediMail version requirements. The requirements are as follows:

2.1.2.1 Operating System Requirements

- Windows Vista
- Windows XP
- Windows 2003
- Windows 2000

2.1.2.2 IncrediMail Version Requirements

Supported IncrediMail versions:


- IncrediMail Xe
- IncrediMail Premium

2.2 Downloading Kernel for IncrediMail for the First Time

After checking your computer with the prescribed system requirements for Kernel for IncrediMail, you can download and install the software on your computer. You can buy the full version of the software from any one of our authorized resellers– Element5, Asknet and 2CO.

If you want to try using Kernel for IncrediMail before buying it, you can download the evaluation version from the following link:

 You can recover .imm, .imh, .imb files saved on your system by using the evaluation version of Kernel for IncrediMail; however, the repaired file will not be saved until you purchase the full version of the software.

2.3 Install Kernel for IncrediMail

After downloading the installer file for Kernel for IncrediMail, you can install the software by running the file.

To install Kernel for IncrediMail:

1. Double-click the Kernel for IncrediMail installer. Follow the on-screen instructions.

The **Setup Installation Complete** screen will be displayed.

2. Click **Finish** to launch the software.

2.4 Start Kernel for IncrediMail

To start Kernel for IncrediMail:

Click the **Start → All Programs → Kernel for IncrediMail**

Alternatively, you can launch Kernel for IncrediMail by double-clicking the shortcut icon available on the Desktop and Quick Launch icon.

2.5 Uninstall Kernel for IncrediMail


You may need to uninstall and re-install Kernel for IncrediMail. To uninstall Kernel for IncrediMail:

1. Click the **Start → All Programs → Kernel for IncrediMail → Uninstall Kernel for IncrediMail**



A warning message will be displayed.

2. Click '**Yes**' to uninstall Kernel for IncrediMail.

 Before proceeding to uninstall Kernel for IncrediMail, you must ensure that the software is not running on your computer.

You can alternatively uninstall Kernel for **IncrediMail** from the **Control Panel** by performing the following steps:

1. Click the **Start Menu → Control Panel** and then double click the **Add or Remove Programs** icon.
2. Select **Kernel for IncrediMail** and click **Remove**. A warning message will be displayed.
3. Click **Yes** to uninstall Kernel for IncrediMail.

3. Software Interface

Now that Kernel for IncrediMail has been installed on your computer, you can start using the software after getting acquainted with the software interface.





3.1 Tool-bar

3.2 Buttons Used

Following are the buttons used throughout the repairing process.

	Click to proceed with the repairing process
	Click to stop the repairing process
	Click to save the recovered emails
	Click to go back to the previous window

4. Recovering Lost Mails

Now that you have complete familiarity of the user interface of Kernel for IncrediMail, you are ready to repair .imm, .imh files. To repair files:

1. Launch Kernel for IncrediMail.

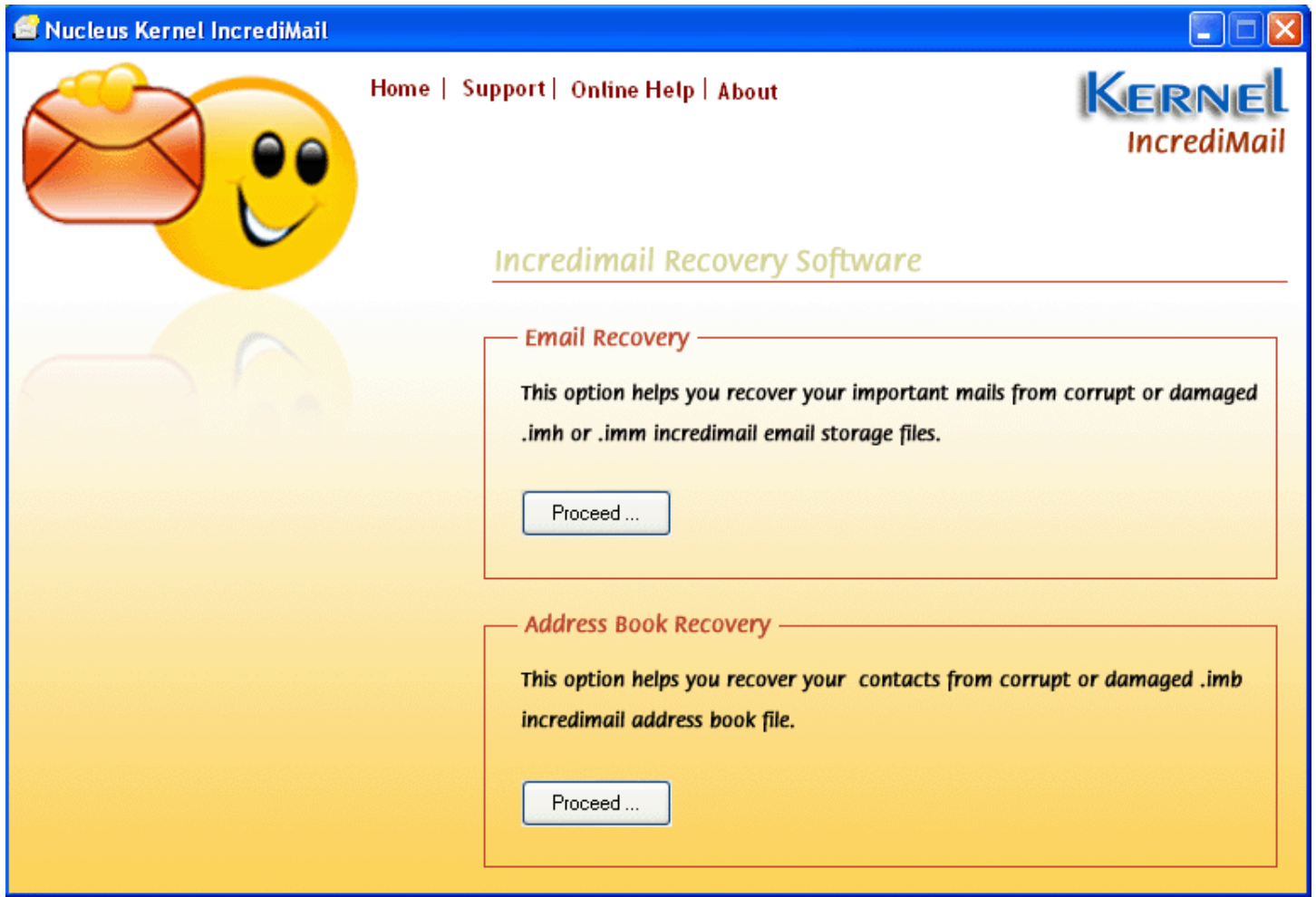


Figure 4.1: Main Window: Kernel for IncrediMail

2. From **Email Recovery** section click **Proceed** to continue.

A window pops-up which let you select the corrupt .imm file that is to be repaired.

3. Select corrupted .imm file and click **Open** button to repair the selected file.

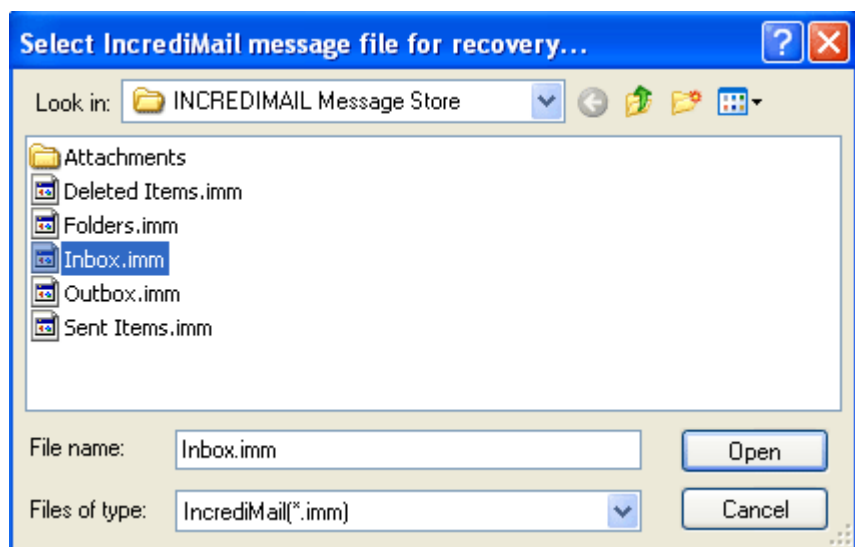


Figure 4.2: Select File for Recovery

Software starts the repairing process and shows the list of repaired mails.

4. Select the repaired mail to see the Preview. A menu appears with the option **Preview Mails**; select it to generate the preview.

After selecting the Mailbox, Kernel for IncrediMail will generate the preview.

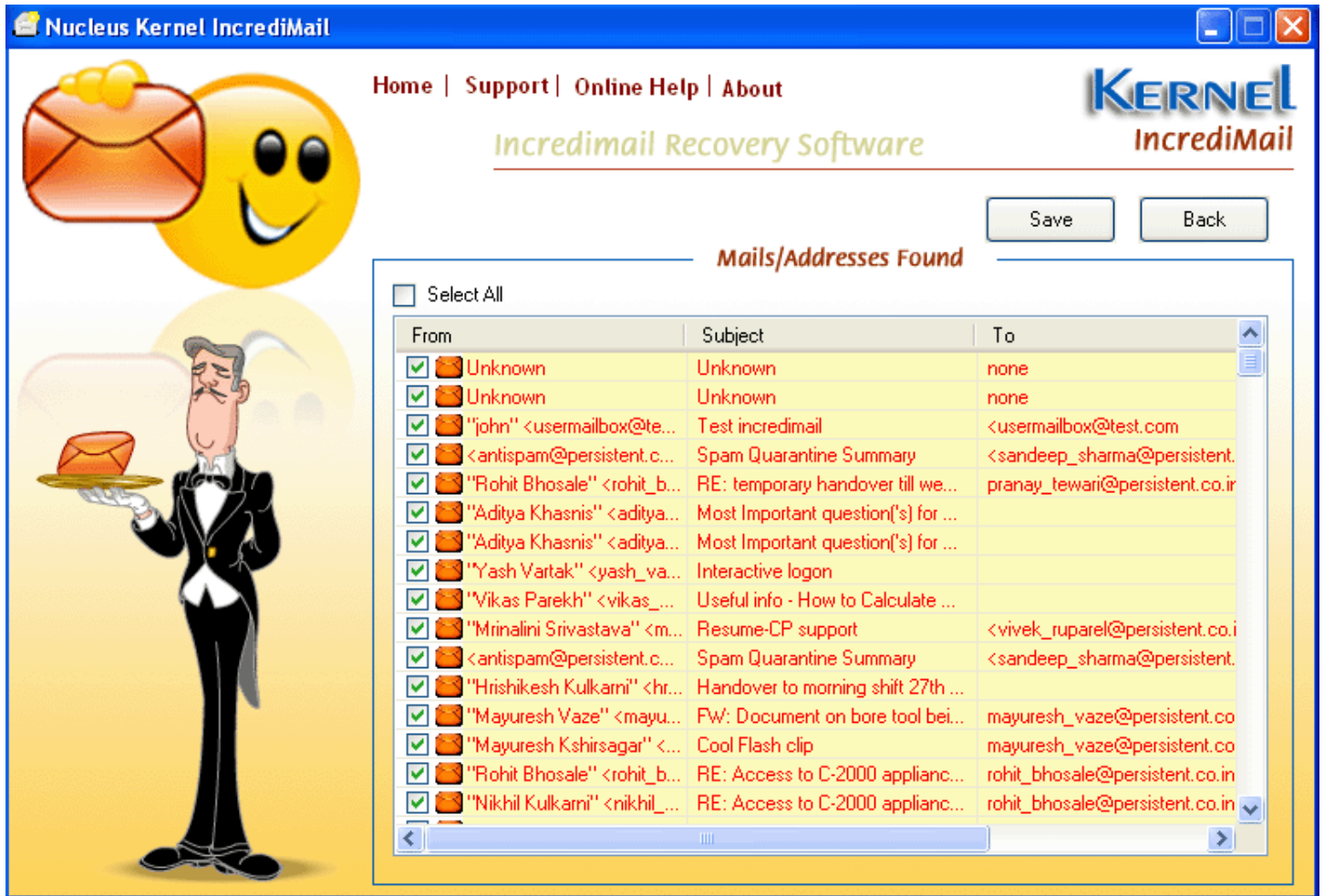


Figure 4.3: Preview of Recovered Mails

5. Select **Save** button to save the recovered emails.
6. After selecting the Save button, **Browse for Folder** window appears which asks for desired location to save the recovered data.

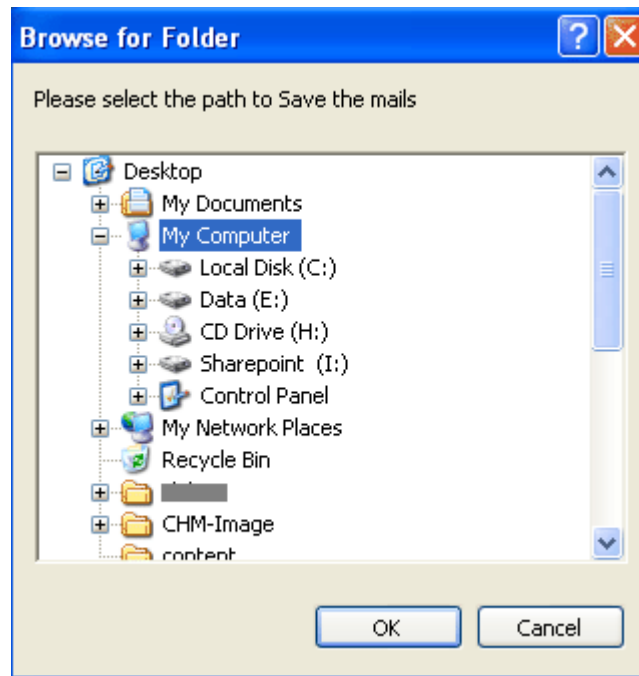


Figure 4.4: Select Folder to Save Recovered Mails

7. Choose the desired location and click **OK**.

5. Recovering Address Book Items

To repair address book (.imb) files, consider the following steps:

1. Launch Kernel for IncrediMail.

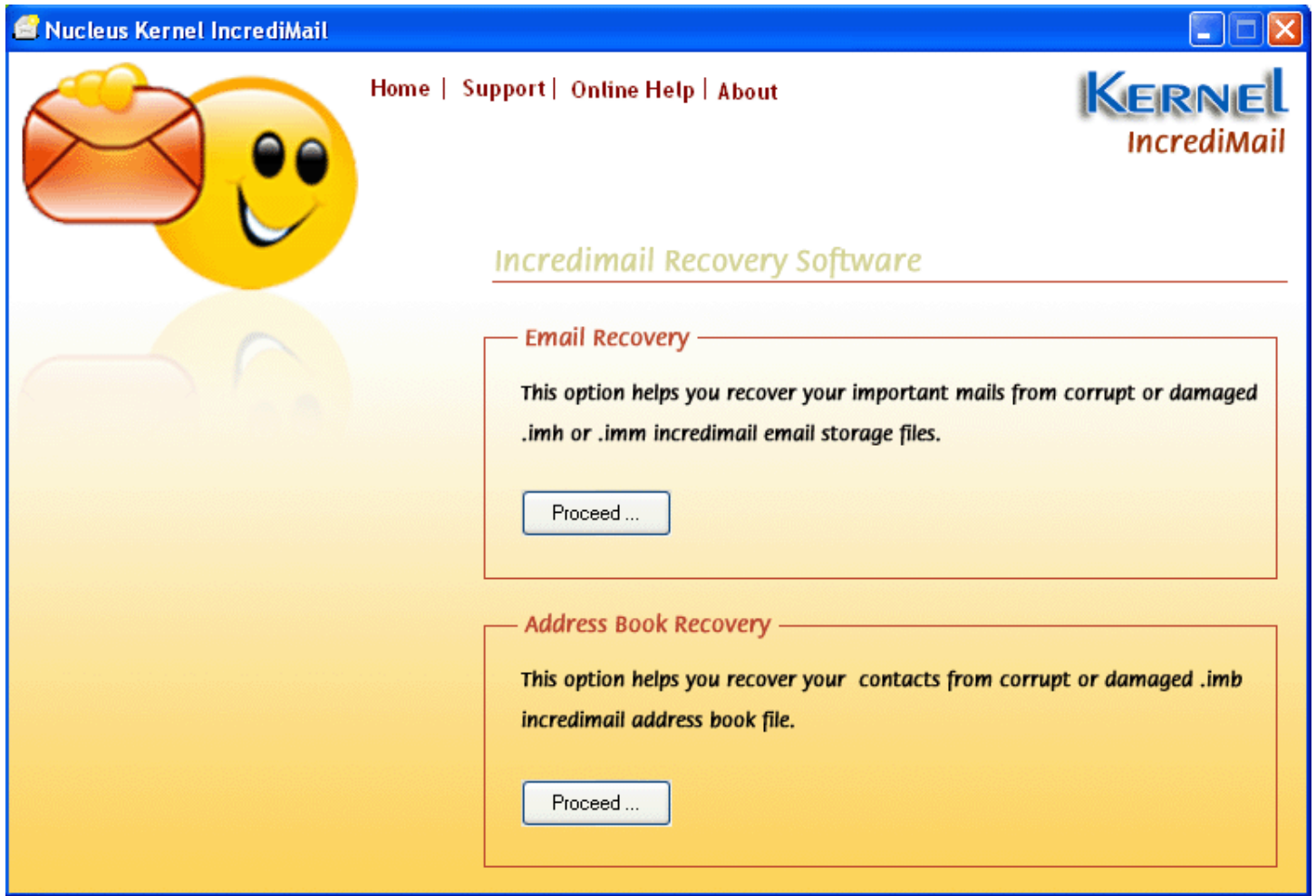


Figure 5.1: Main Window: Kernel for IncrediMail

2. From **Address Book Recovery** section to recover contacts from corrupt or damaged .imb files and click **Proceed** button to continue. A window pops-up which lets you select the corrupt .imb file that is to be repaired.
3. Select corrupted .imb file and click **Open** button to repair the selected file.

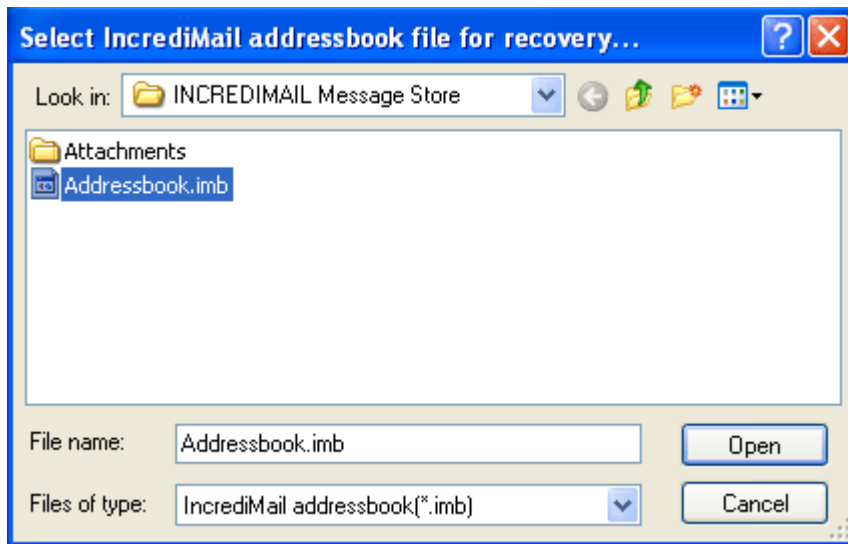


Figure 5.2: Select IncrediMail Address Book File

Software starts the repairing process and shows the list of repaired .imb files.

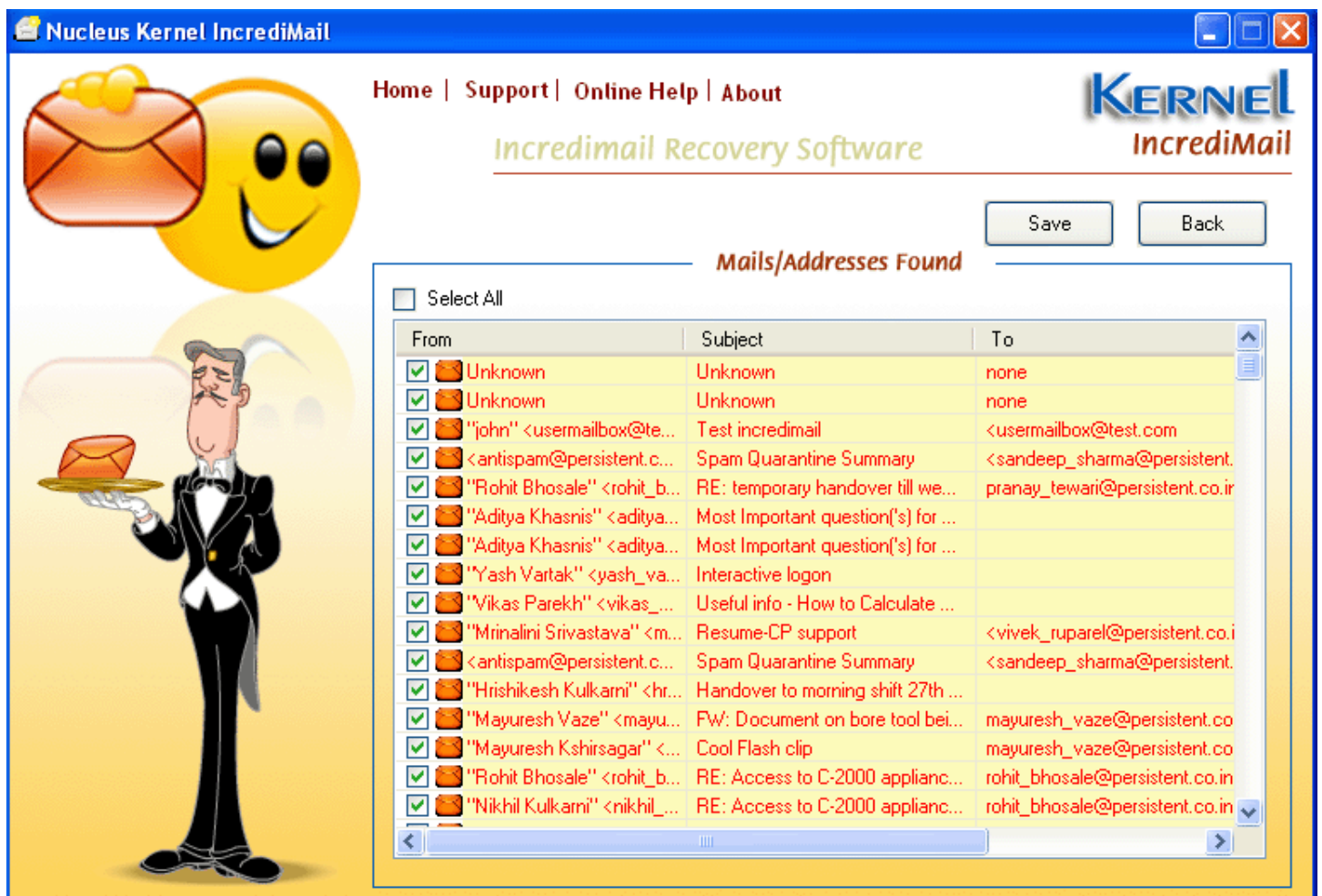


Figure 5.3: Preview of Recovered Address Book

4. Select **Save** button to save the files.
5. After selecting the Save button, **Browse for Folder** window appears which asks for desired location to save the recovered data.

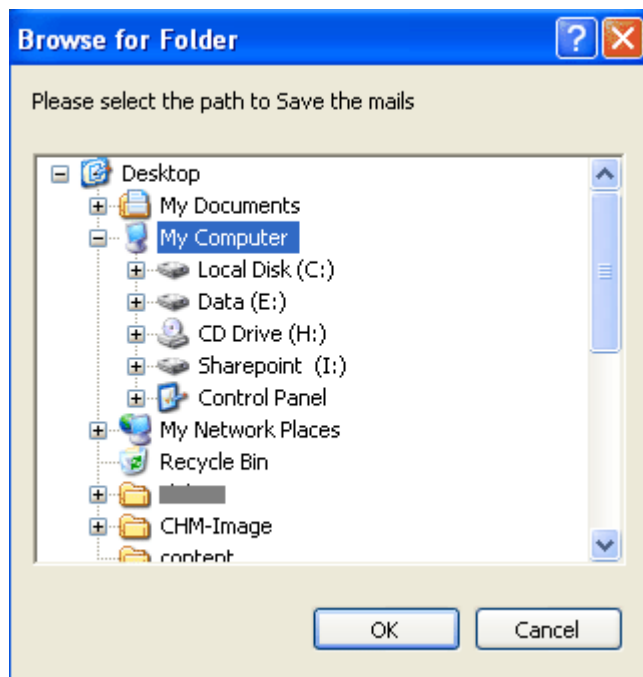


Figure 5.4: Select Folder to Save Recovered Address Book

6. Choose the desired location and click **OK**.

6. Full Version

Although you can use Kernel for IncrediMail evaluation version for free and experience the capabilities of the software, there are certain features that are not available in the evaluation version.

6.1 Requirement of Full Version

By using the evaluation version of Kernel for IncrediMail, you can repair corrupt .imh, .imm, .imb files; however, you cannot save the repaired files.

You will need to buy the full version of the software to save the recovered IncrediMail files.

6.2 Purchasing Full Version

You can buy the full version of Kernel for IncrediMail from any one of our authorized resellers – Element5, Asknet and 2CO.

As soon the purchase transaction with our resellers gets completed, our sales team will send you an email comprising the URL to download the full version of Kernel for IncrediMail and activation details of the software.

8.1 Common Issues

Why does Kernel for IncrediMail have limitations in evaluation copy?

Kernel IncrediMail Address Book and Mails Recovery (evaluation copy) usually checks the intensity of corruption and data but it doesn't allow you to save the repaired files. Purchasing the full version of the software allows you to save repaired files in the desired location.
