1.1 Using this Manual

Welcome to the user manual of Kernel for PST Split, an efficient tool to split large sized PST files. This user manual is intended to guide users on using Kernel for PST Split. We suggest that first time users should read this user manual completely and carefully before proceeding to use the software. 1.2 Introduction to Kernel for PST Split

Kernel for PST Split is a comprehensive PST split solution devised especially to split PST files into small chunks and create new split PST files. Large-sized PST files exhibit inconvenient accessibility and affect the overall performance and speed of Outlook. The software breaks the PST files into smaller files thus enhances speed of Outlook.

Kernel for PST Split allows you to split PST file based on date, email ID, and size. In addition, the software facilitates you to make single PST file for every folder and extract selected folders into a PST file. This PST Split tool allows you to break all items and folders available in the PST such as Contacts, Calendar, Journals, and Email Folders (Inbox, Outbox, Deleted Items, Sent Items, and Drafts etc).

Kernel for PST Split is helpful in the following scenario:

- For increasing overall working performance of Outlook
- To avert 2 GB file size limitation issue due to increasing size of PST
- For avoiding PST file corruption due to over sizing of PST
- Need to manage PST files in an easiest and convenient manner

1.3 Key Features

Distinguished features of Kernel for PST Split software are:

- Multiple split options for convenient splitting of PST
- Splits PST files quickly and easily
- Comprehensive splitting process. Splitting of all items of Outlook mailboxes, such as emails, contacts, calendars, journal, tasks, etc.
- Splits shared, separately saved, and in-use PST files
- Creation of independent small-sized PST files
- Preserves data integrity
- Retains accurate meta data after the splitting process is completed
- Eases management of PST files
- Self-explanatory graphical user interface
- Supports all versions of MS Outlook

1.4 System Requirements

Make sure that your computer is appropriately configured to run Kernel for PST Split. Following are the minimum system requirements for installing and running Kernel for PST Split:

2. Understanding the User Interface

2.1 Welcome Screen

Now, when you have understood the features and potential of Kernel for PST Split, you are ready to get a hand on experience of the software. When you launch the Kernel for PST Split software, the following welcome screen appears.

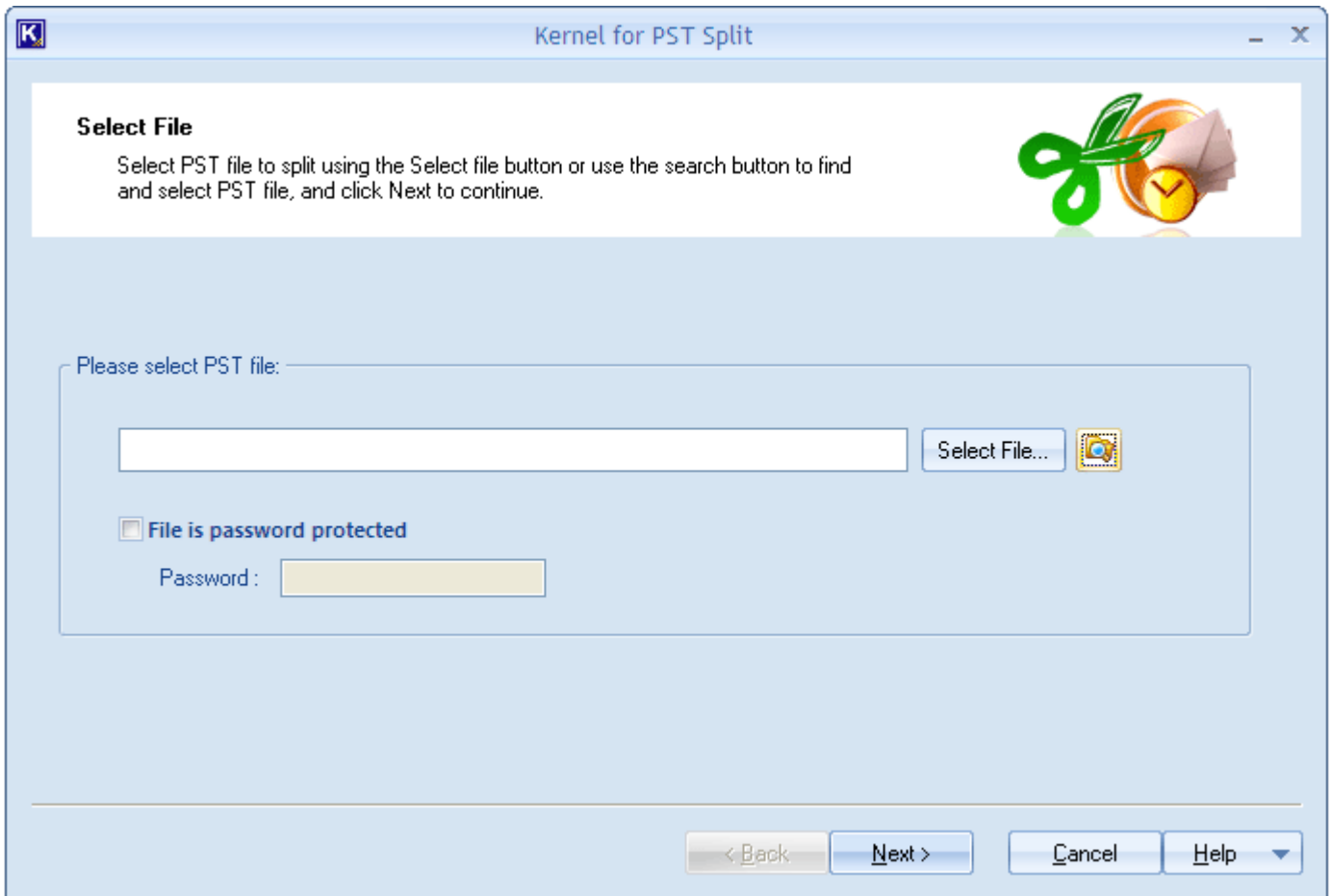













Figure 2.1: Welcome Screen

This screen allows you to select the PST file for splitting. If you know the location of the PST file that you want to split, then use the **Select File** button to select the file and continue with the splitting process.

However, you can use the **Search PST File(s)** () button to search the PST file in a particular drive or folder. If the PST file you want to search is encrypted or password protected, then select the **File is Password Protected** check box and enter the password in the **Password** field.

2.2 Buttons Used

Following are the main buttons used in the software for making the process of splitting PST files easy and fast:

Button	Button Description
	Allows you to select the PST file when its location is known
	Allows you to search PST files present in the system whose location is unknown to the user
	Takes you to the previous Window
	Takes you to the next step
	Opens the user's help guide of Kernel for PST Split
	Cancels the current process and closes the program
	Completes the process
	Stops the currently running process
	Allows you to add required time duration or email id (manually)
	Removes the selected duration/email ID for splitting PST file
	Searches PST file at the browsed location

3. Install and Uninstall

3.1 Install the Software

Now, when you are well acquainted with the software features and its benefits, let us install the software to take its advantage. However, before installing the software, you must confirm that the software installer file is available on your computer system or at any other storage media from where you want to install the software. If the file is not available then obtain the installer file of Kernel for PST Split from - <http://www.nucleustechnologies.com/download-pst-split.html>


After you have made sure that, the installer file is available, follow the below given steps to install the Kernel for PST Split software:

1. Double-click the Kernel for PST Split installer file.
2. Follow the on-screen instructions. After the installation process is completed, the “**Setup Installation Complete**” message will be displayed.
3. Click the **Finish** button to launch the software.

3.2 Uninstall the Software

To uninstall Kernel for PST Split from your system, you can use any of the two methods mentioned below:

- Uninstall from Windows Start Menu
- Uninstall from Control Panel

 While un-installing, make sure that no component of Kernel for PST Split software is running in the system background.

Uninstall from Windows Start Menu

To uninstall Kernel for PST Split from Windows Start menu, follow these steps:

1. Click the **Start** button from the Windows menu.
2. Select **All Programs > Kernel for PST Split > Uninstall Kernel for PST Split**. A warning message before un-installing will be displayed on the screen.
3. Click the **Yes** button to uninstall the software.

Kernel for PST Split is now successfully uninstalled from your computer system.

Uninstall from Control Panel

To uninstall Kernel for PST Split from Control Panel, follow these steps:

1. Click **Start > Control Panel**. The Control Panel window opens up.
2. Double-click the **Add or Remove Programs** icon. A list of the programs installed on your computer system appears.
3. Select **Kernel for PST Split** and click the **Remove** button. A warning message before un-installing the software will be displayed on the screen.
4. Click the **Yes** button to un-install the software.

Kernel for PST Split is now successfully uninstalled from your computer system.

4. Splitting PST file

4.1 Split PST File Based on Date

Splitting PST files based on date allows you to split PST file for a particular duration. When the **Split file based on date** option is selected, a new PST file is created containing only the emails received or sent during that specified duration. The integrity of original PST file is kept intact. Following steps help you to split the selected PST file based on the specified duration:

1. Launch the Kernel for PST Split software. The Welcome screen appears:

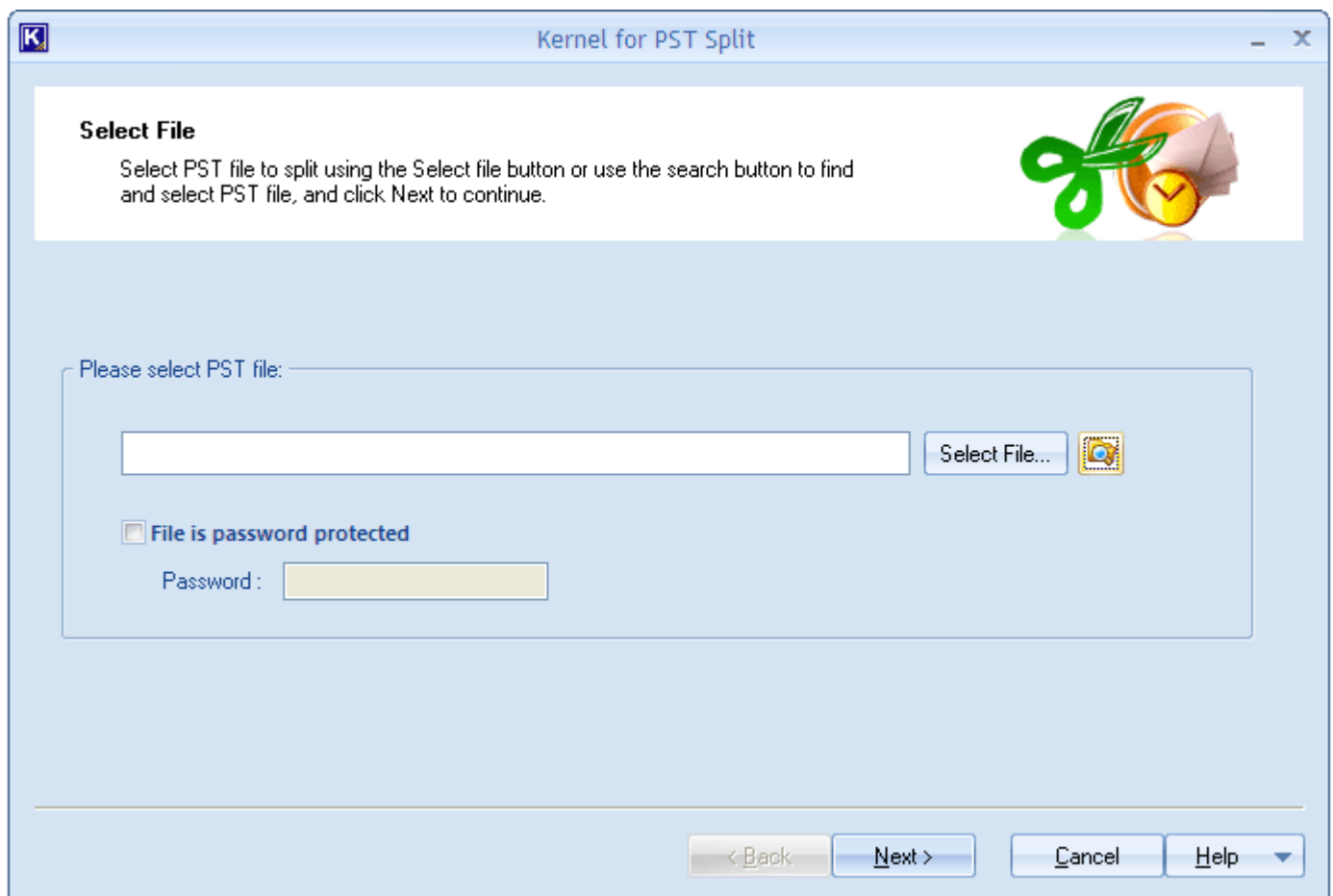


Figure 4.2: Main Window

2. Click the **Select File** button to select the PST file that you want to split. Click the **Select File** button only when you know the location of PST file otherwise click the **Search PST File (s)** button to search the PST file on your computer.
3. In case the PST file is encrypted or password protected, select the **File is password protected** option and enter the password in the **Password** field.

4. After selecting the PST file to split and specifying the password (if required), click the **Next** button to continue. The "Select Split Option" page appears:

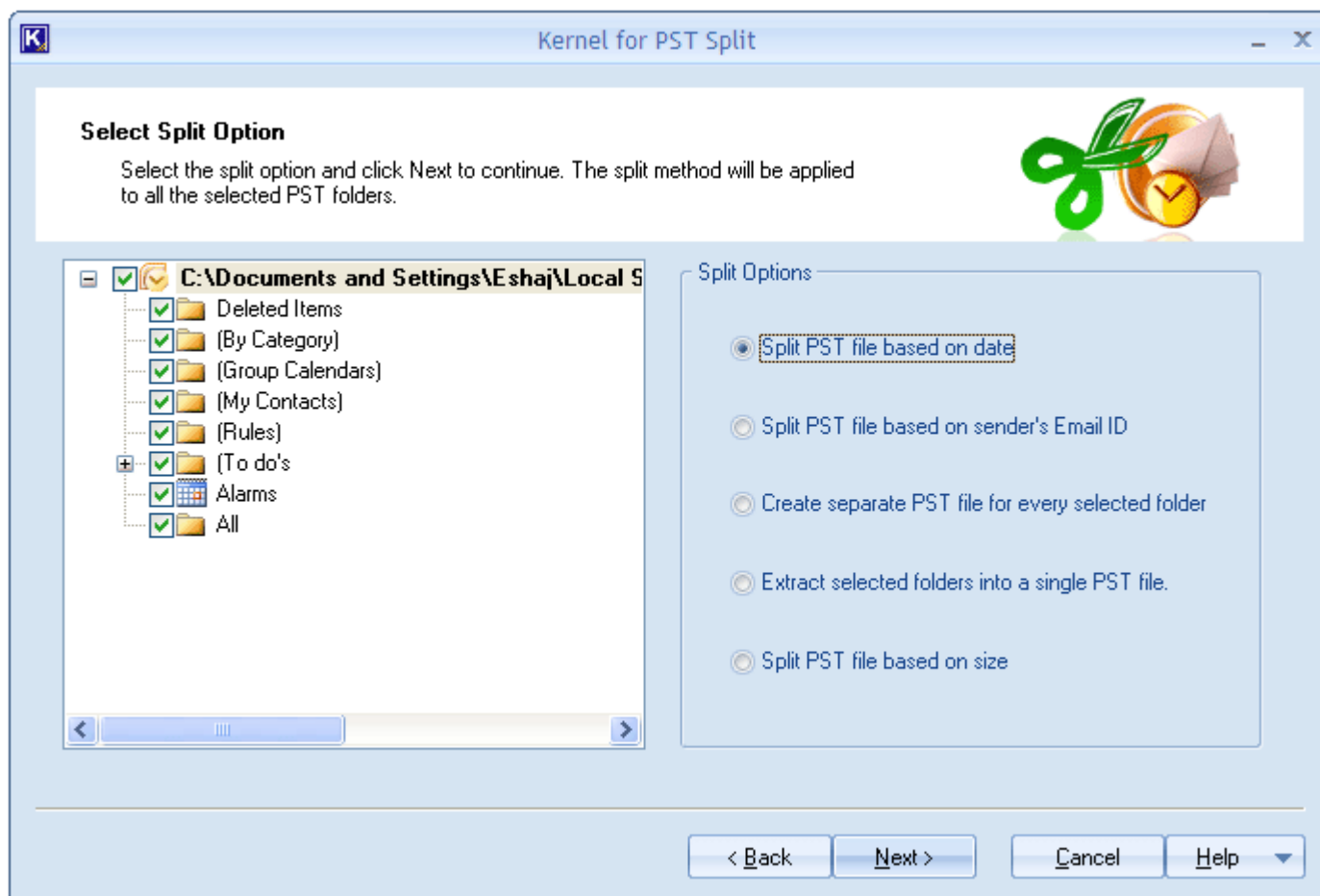


Figure 4.2: Displaying Select Split Option Page

5. Select the folders that you want to split from original PST file. Then select the **Split PST file based on date** option to initiate the split process.

Click the **Next** button. The “Select Date Range” page appears:

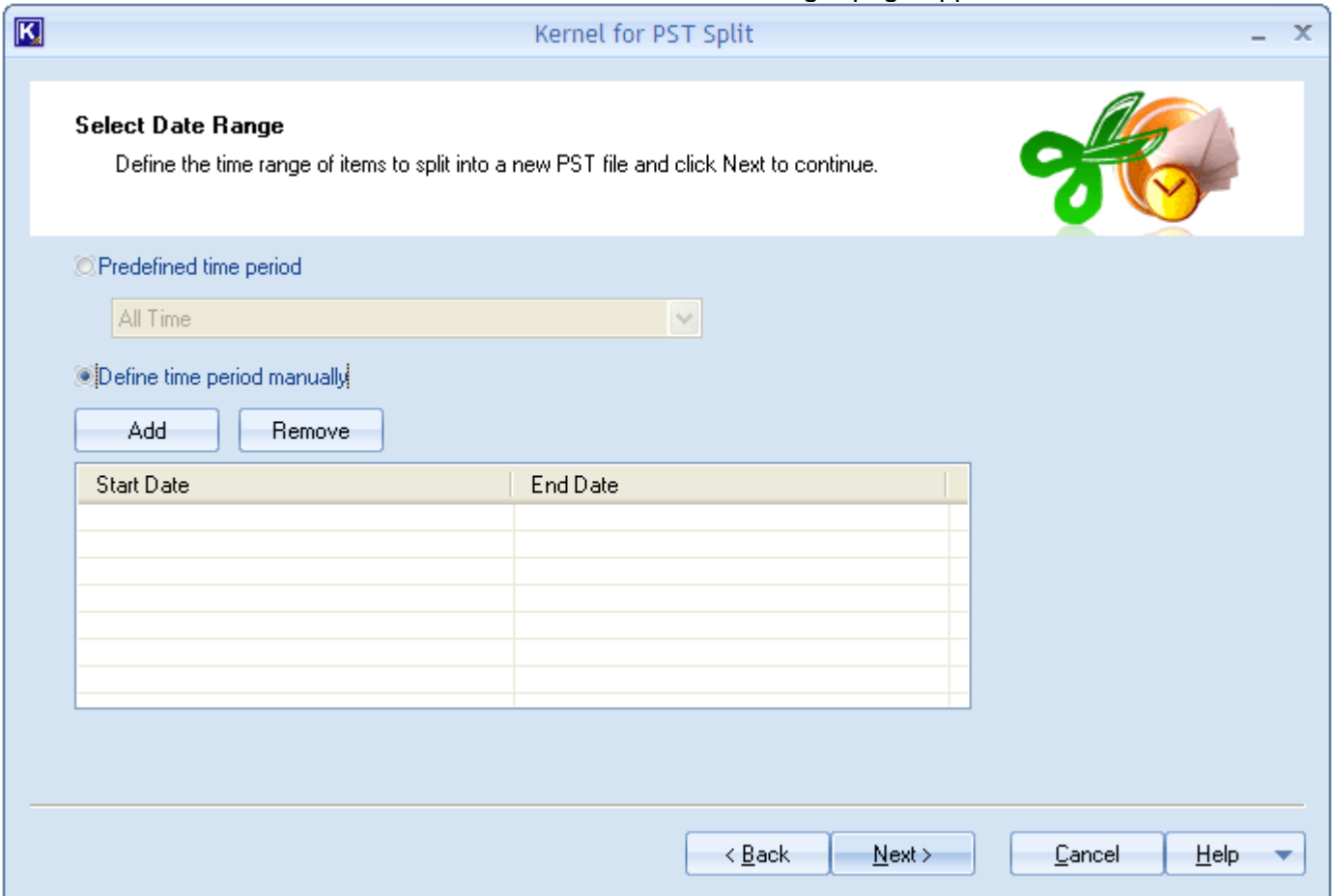


Figure 4.3: Select Date Range

6. Now, select the specific time duration for splitting the PST file by selecting either **Pre-defined time period** or **Define time period manually** option.

Selecting Pre-defined time period option allows you to choose from options like Latest, 1 week, 2 week, 1 month, 2 month, 1 year, and so on for splitting the PST for specific time period. While selecting the Define Time period manually option enables you to define a duration for splitting the PST.

7. On selecting a desired option, click the **Next** button. Software now displays the “Browse for Folder” dialog box to help you select a location to save the split PST file:

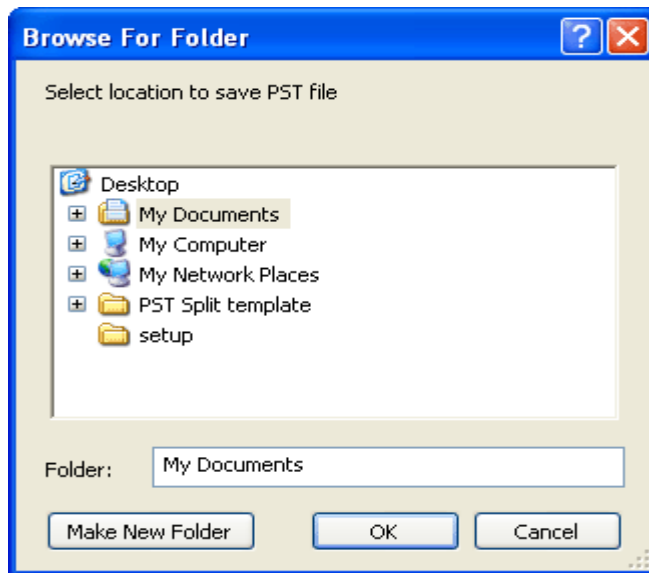


Figure 4.4: Specifying Location to save the split PST File

- Specify the destination and click the **OK** button to continue. The “Split in progress” page appears showing the ongoing splitting process:

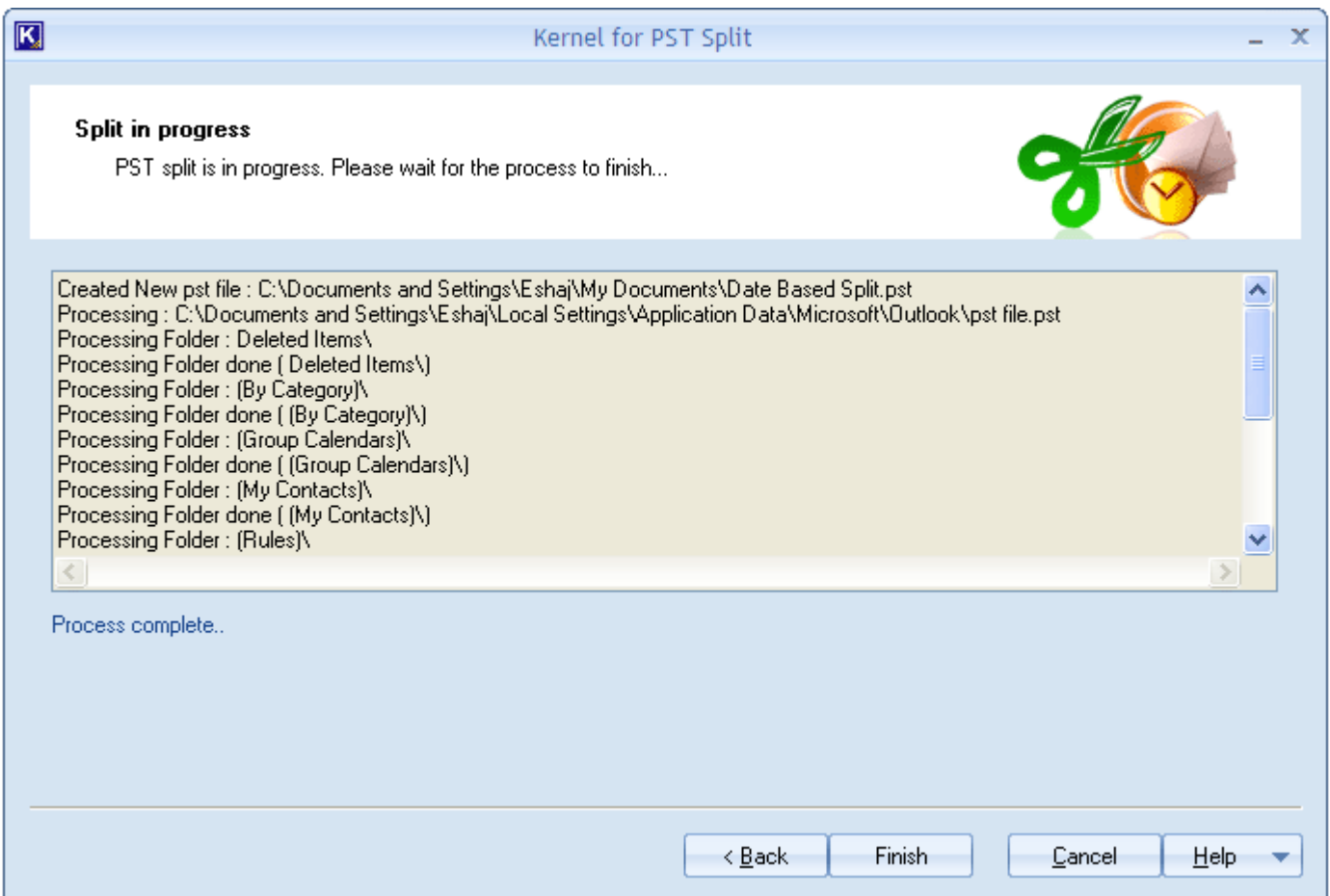


Figure 4.5: Displaying the Split Process

9. After the splitting process is completed, the success message appears on your computer screen depicting that the splitting process has completed.

4.2 Split PST File Based on Sender's Email ID

Splitting the PST file based on sender's email ID allows you to create a PST file containing the emails sent or received from a specific email ID. When you select the **Split PST file based on Sender's email ID option**, a new PST file is created containing only the emails received/sent to a specific email ID. You can select multiple email IDs. Consider the below-mentioned steps to split PST based on the sender's email ID:

1. Launch the software. The Welcome screen appears.
2. Click the **Select File** button to select the PST file that you want to split. Click the **Select File** button only when you know the location of PST file otherwise click the **Search PST File (s)** button to search the PST file on your computer.
3. In case the PST file is password protected, select the **File is password protected** option and enter the password in the **Password** field.
4. Click the **Next** button to continue. The "Select Split Option" page appears:

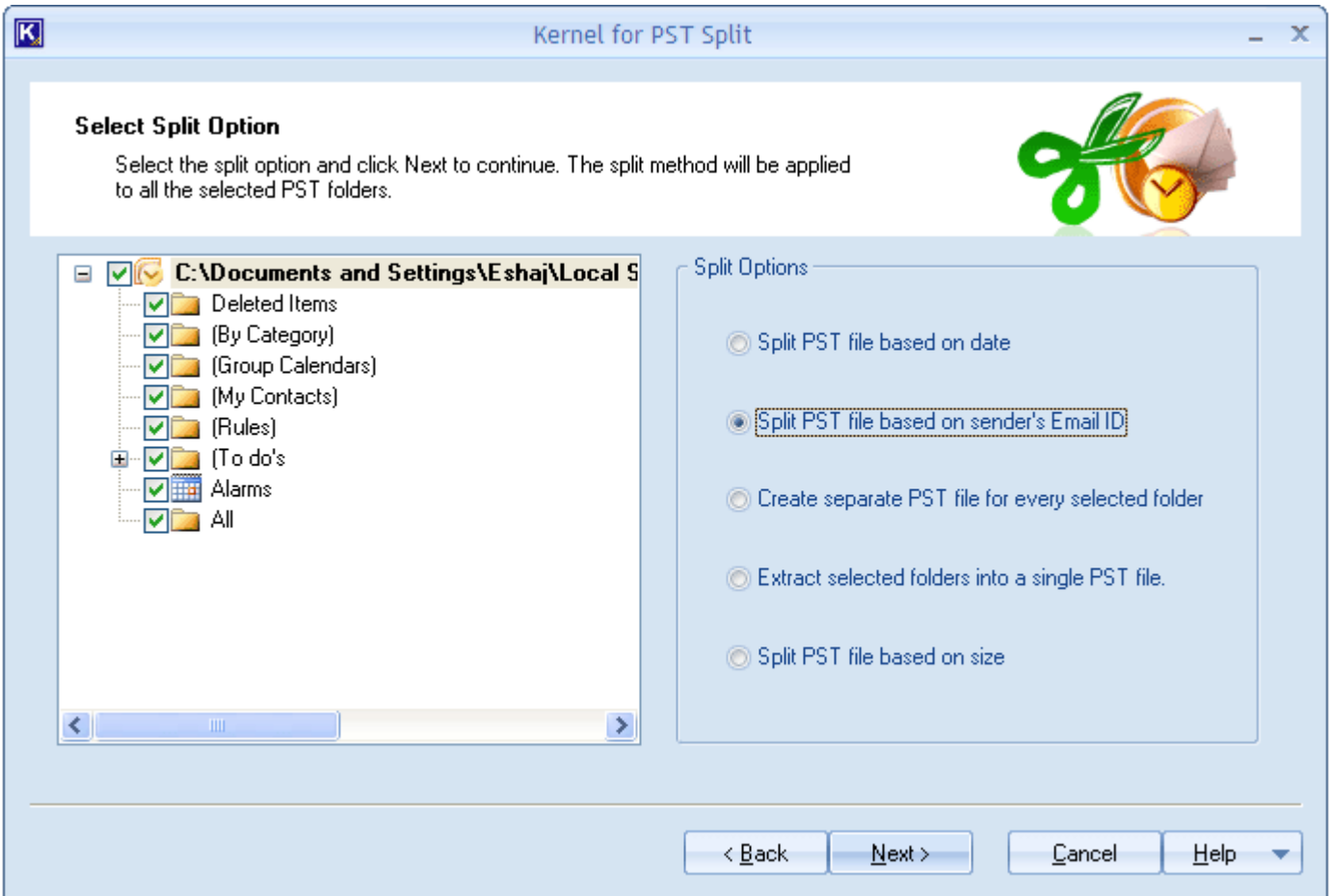


Figure 4.6: Selecting the Split PST File Based on Sender's Email ID Option

5. Select the email folder(s) that you want to split and then select the **Split PST file based on sender's Email ID** option.

Click the **Next** button. The “Select Email Addresses” page appears:

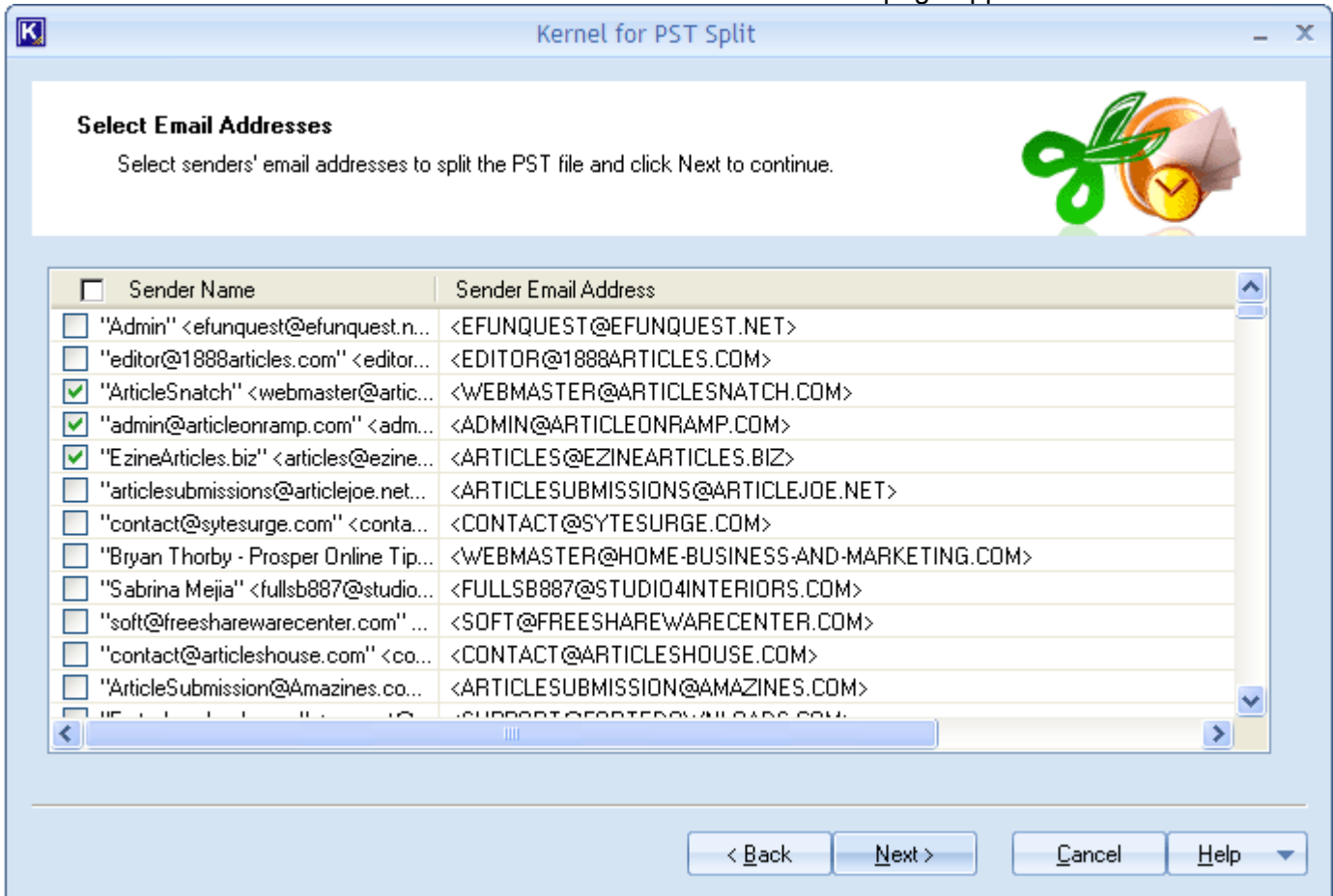


Figure 4.7: Selecting Email Addresses

6. Select the specific email ID(s) by selecting the checkbox beside the sender's emails enlisted by the software.
7. Click the **Next** button to continue. Software now displays the “Browse for Folder” dialog box to help you select a location to save the split PST file.
8. Specify the destination and click the **OK** button to continue. The “Split in progress” page appears showing the ongoing splitting process.
9. After the splitting process is completed, the success message appears on your computer screen depicting that the splitting process has completed.

4.3 Create Separate PST File for Every Selected Folder

The **Create separate PST file for every selected folder** option allows you to build single PST file for every folder available in the PST file. A PST file is created for each folder or sub-folder available in the original PST file without hampering its data integrity. Let us execute the following steps to split PST using the **Create separate PST file for every selected folder** option:

1. Launch the software. The Welcome screen appears.
2. Click the **Select File** button to select the PST file that you want to split. Click the **Select File** button only when you know the location of PST file otherwise click the **Search PST File (s)** button to search the PST file on your computer.
3. In case the PST file is encrypted or password protected, select the **File is password protected** option and enter the password in the **Password** field.
4. Click the **Next** button to continue. The "Select Split Option" page appears:

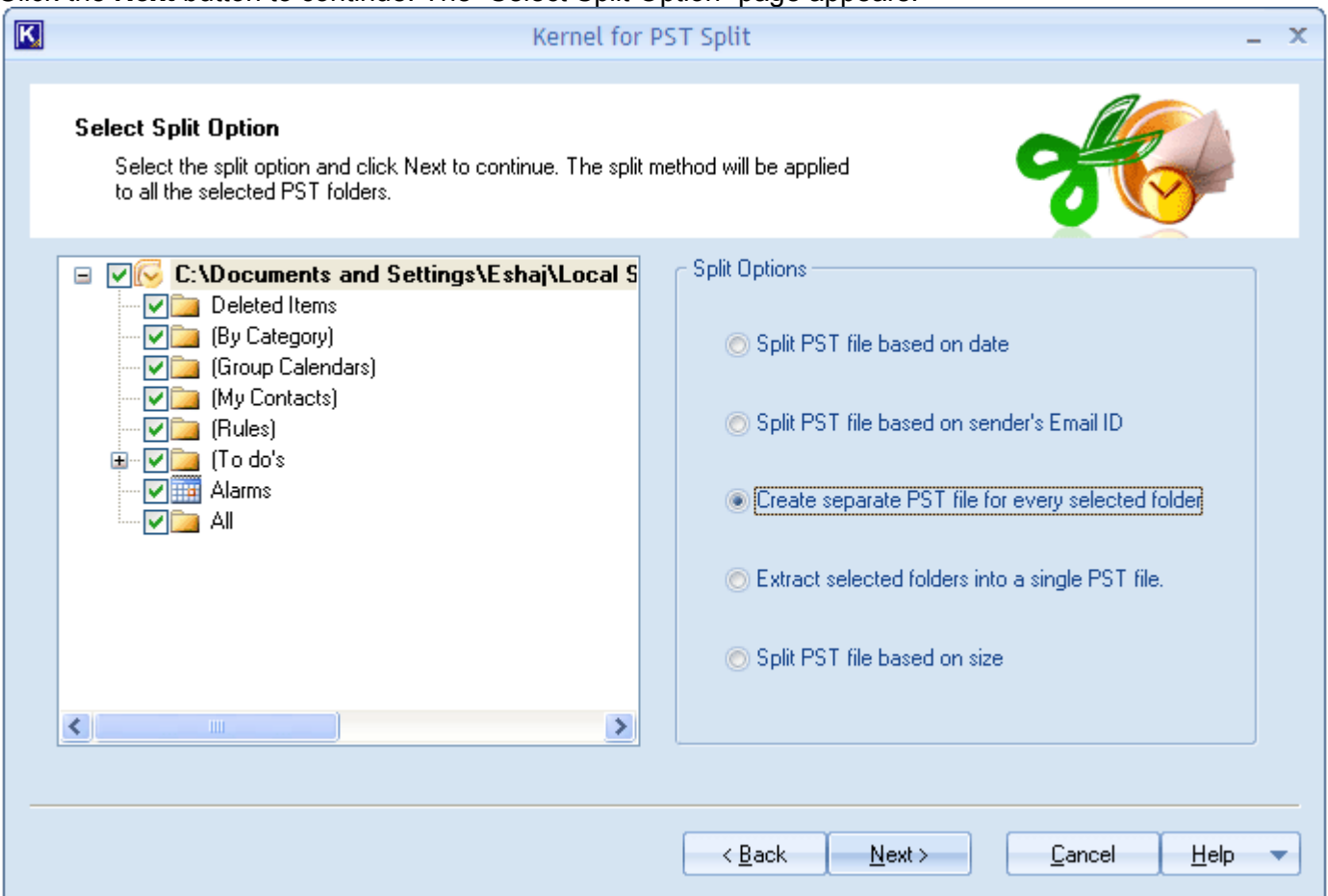


Figure 4.8: Displaying the Select Split Option Page

5. Select the folders that you want to split. Then select the **Create separate PST file for every selected folder** option to initiate the split process.
6. Click the **Next** button. Software now displays the "Browse for Folder" dialog box to help you select a location to save the split PST file.
7. Specify the destination and click the **OK** button to continue. The "Split in progress" page appears showing the ongoing splitting process.

8. After the splitting process is completed, the success message appears on your computer screen depicting that the splitting process has completed.

4.4 Extract Selected Folders into a Single PST File

The **Extract selected folders into a single PST file** option facilitates you to extract the data of multiple selected folders into a single folder only. Following steps help you to use the **Extract selected folders into a single PST file** option:

1. Launch the software. The Welcome screen appears.
2. Click the **Select File** button to select the PST file that you want to split. Click the **Select File** button only when you know the location of PST file otherwise click the **Search PST File (s)** button to search the PST file on your computer system.
3. In case the PST file is encrypted or password protected, select the **File is password protected** option and enter the password in the **Password** field.
4. After selecting the PST file to split and specifying the password (if required), click the **Next** button to continue. The "Select Split Option" page appears:

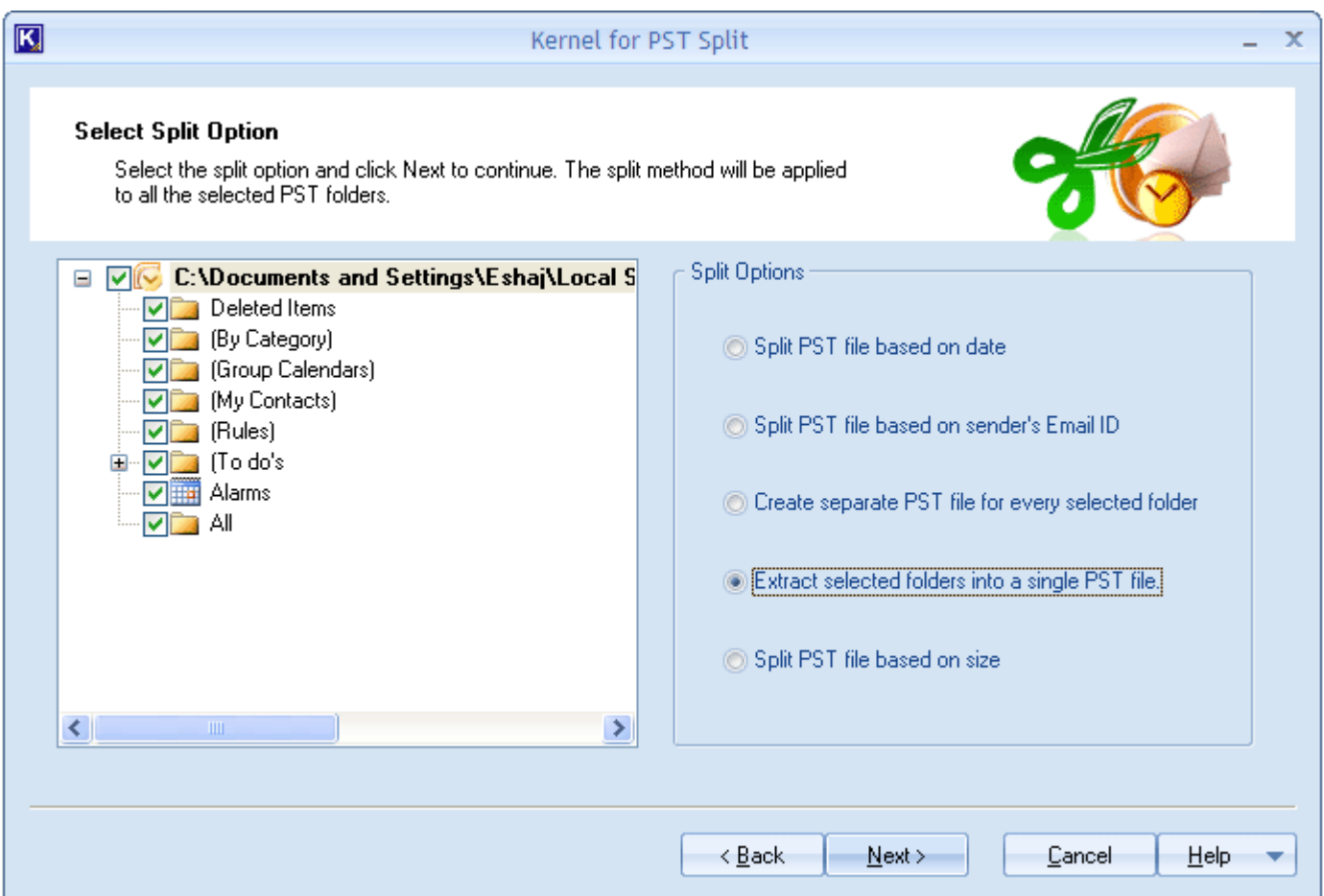


Figure 4.9: Extract Selected Folders into a Single PST File

5. Select the folders that you want to split.
6. Select the **Extract selected folders into a single PST folder** option to initiate the split process and click the **Next** button. Software now displays the “Browse for Folder” dialog box to help you select a location to save the split PST file.
7. Specify the destination and click the **OK** button to continue. The “Split in progress” page appears showing the ongoing splitting process.
8. After the splitting process is completed, the success message appears on your computer screen depicting that the splitting process has completed.

4.5 Split PST File Based on Size

The **Split PST file based on size** option allows you to split large-sized PST file on the basis of size or number of divisions required. Execute the following steps to split PST based file based on its size:

1. Launch the software. The Welcome screen appears.
2. Click the **Select File** button to select the PST file that you want to split. Click the **Select File** button only when you know the location of PST file otherwise click the **Search PST File (s)** button to search the PST file on your computer system.
3. In case the PST file is encrypted or password protected, select the **File is password protected** option and enter the password in the **Password** field.

After selecting the PST file to split and specifying the password (if required), click the **Next** button to continue. The "Select Split Option" page appears:

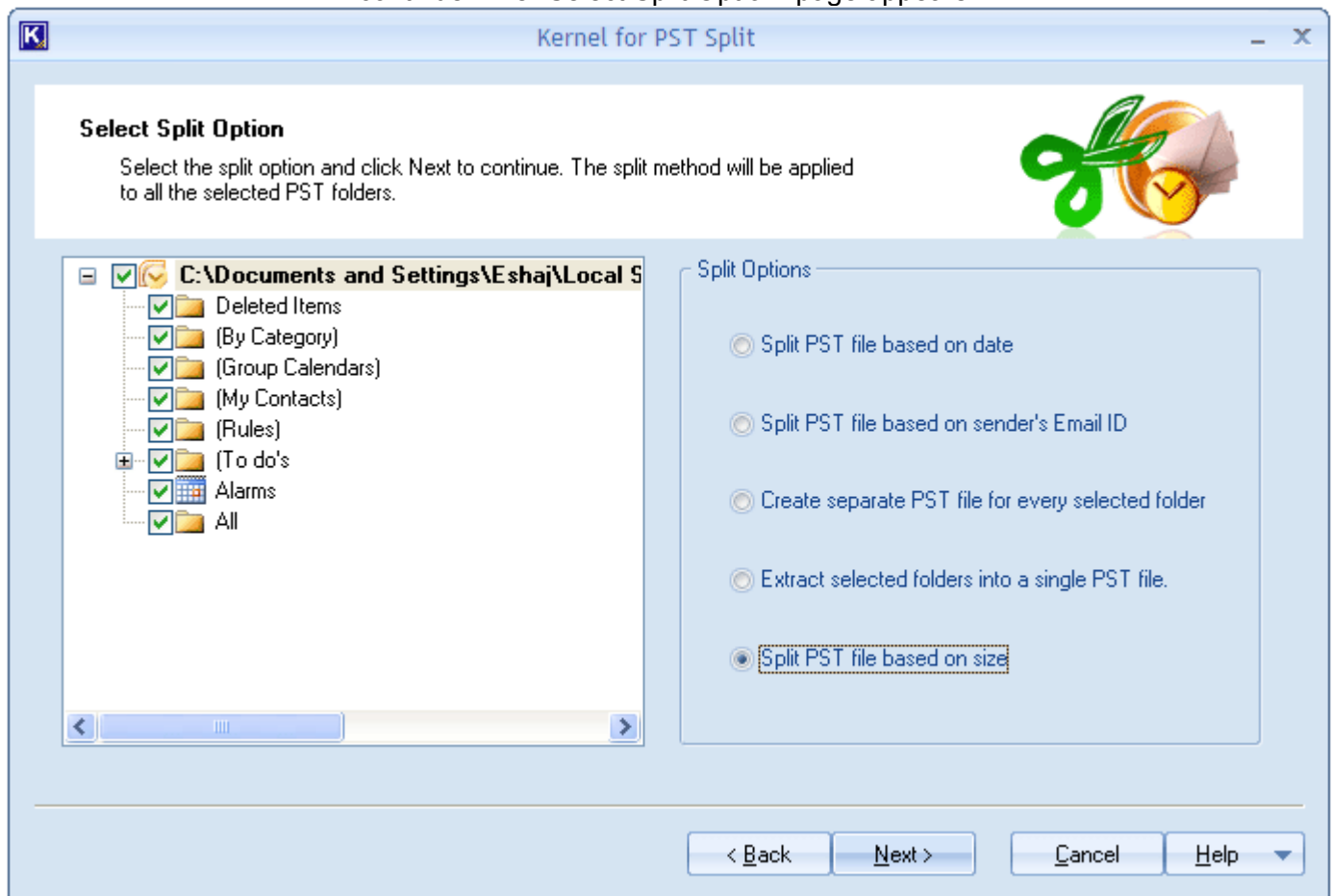


Figure 4.10: Split PST File Based on Size

4. Select the folders that you want to split.

Select the Split PST file based on size option to initiate the split process and click the **Next** button. The “Enter Split Size” page appears:

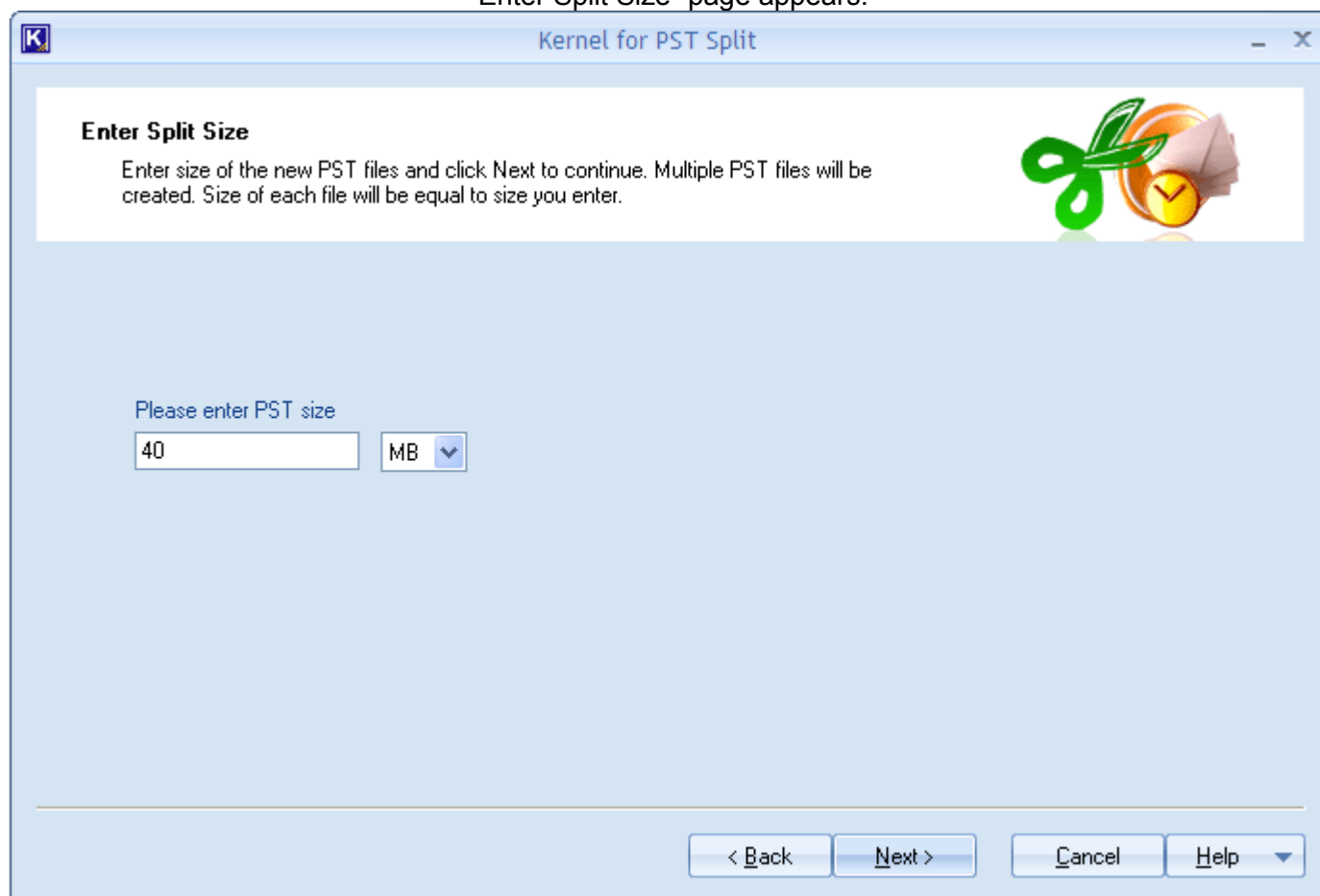


Figure 4.11: Displaying the Enter Split Size Page

5. Enter the PST size that you want for every split PST file in the **Please enter PST size** field. After specifying the size, select unit, which can be either KB, MB, GB or TB.
6. Click the **Next** button to continue. Software now displays the “Browse for Folder” dialog box to help you select a location to save the split PST file.
7. Specify the destination and click the OK button to continue. The “Split in progress” page appears showing the ongoing splitting process.
8. After the splitting process is completed, the success message appears on your computer screen depicting that the splitting process has completed.

5. Download Purchase and Register

5.1 Free Download

Kernel for PST Split is available for FREE download. The trial version saves only 5 items of each folder to the new PST file. To overcome this limitation, user needs to purchase the software for saving required number of items to new PST file.
